- A. Ms. Bereswill called the meeting to order at 7 PM.
- B. Ms. Bereswill presented the minutes for approval. Ms. Chewning made a motion to accept the meeting minutes for the September 24, 2012. The motion was seconded by Ms. Murphrey and approved by unanimous vote.
- C. Ms. Howerton discussed the upcoming Teen Read Fest. Judging for Teen Read Fest was held October 10th and 11th. There were 300 written entries from Middle School and High School Teens. We received 18 film entries and 21 reading posters. Winners were selected and the cash awards will be presented at the celebration at the Board of County Commissioner Chambers on November 8th at 7 p.m.
- D. Ms. Howerton gave the Library Advisory Board an update on the Library's events planned for the Seminole County Centennial Celebration. The County Centennial Celebration will run from January 6th to April 20th. The library will present the Sunshine Story Telling Festival, a Centennial event on March 9th at the Central Branch. The Library will present time capsule programs at all branches with the sealing ceremony on April 13th. National Library week is April 13-20th and the theme is Community Matters@ Your Library.
- E. Ms. Howerton and the Library Advisory Board Chair, Regina Bereswill presented information about the Overdrive Digital Bookmobile that will be at Great Day in the

The mobile has a technology petty zoo which will allow people to learn about e-books and e-readers. Ms. Chewning made a motion to invite the Commissioners and the BCC Chairman to the digital bookmobile at Great Day in the Country. The motion was seconded by Ms. Finch and approved by unanimous vote.

Ms. Patten suggested that the Library Advisory Board join in a discussion of the twelve questions that the Library Services Division Manager will be asked regarding plans for the future of library services. The Library Advisory Board agreed to discuss these questions at a future meeting.
