## PROCEDURAL REQUIREMENTS FOR MILLAGE INCREASE

He asked if the Commission thought the e-mail answered their concerns and questions relating to the issues that Mr. McLain brought up.

Mr. Boyko stated he believes it was Mr. McLain's idea to have the public vote on the ad valorem when it comes up or down.

Vice Chairman Strickler stated it was to have a super majority of the BCC to vote and based on State statutes, it is pretty much already in place.

Mr. Dicks stated he believes Mr. McLain brought that up at the last meeting and he read the e-mail and agrees that it is in place. He added with the fact that there is no public to give any input, he doesn't believe the CRC needs to discuss this issue any further.

Mr. Boyko inquired relative to dissolving the Commission or just keep it in abeyance so that if something comes up, the Chairman can call a meeting. Mr. Dicks advised the CRC let a month go by and this meeting was adequately advertised and there is no further interest by the public.
