

# 3<sup>rd</sup> Generation One Cent Local Government Infrastructure Surtax

## **ANNAL REPORT - FISCAL YEAR 2022**

Fiscal year 2022 was the eighth year of the 3<sup>rd</sup> generation one cent local government infrastructure surtax. In year eight (2022) collections for the full fiscal year (Oct – Sep) totaled approximately \$3.7 million. Expenditures for 2022 totaled approximately \$1.2 million.

In fiscal year 2022, funds were expended on the following projects:

- Citywide Paving projects included resurfacing of roadways and parking within Eastmonte Park.
- Intersection improvements with a roundabout study at West Town Parkway & Laurel Street.
- Design pedestrian improvements for Spring Lake Trail.
- Design pedestrian improvements for SR 436 (PedSafe).
- Spring Lake Road Complete Street. Design took place in 2022 and continues in 2023.
- The City received \$500,000 in FDOT state grant funds to install PedSafe connected vehicle technology at the intersections in this corridor. This technology will help prevent crashes between vehicles and pedestrians/bicyclists.

In July 2016, the City and the County entered into an Interlocal agreement to advance projects on the County's 3<sup>rd</sup> generation sales tax major projects list. As part of this agreement, the City is managing multiple projects as summarized below:

- SR 436 Multi-modal Improvements I-4 to 17-92 The construction of the eastern portion of these improvements from Boston Ave to Anchor Rd are incorporated into the construction of the project above was completed in fiscal year 2022. Design of the western portion of this project began in November of 2020 and was completed in fiscal year 2022.
- Altamonte SunRail Station Bicycle and Pedestrian Connectivity Improvements The City has secured \$2.5 million in matching state funds for construction of this project in the current year budget. The design is complete and the project was bid in September 2022 to begin construction once all easements have been secured.

The City expects to fund numerous other projects from the 3<sup>rd</sup> generation sales tax. Accompanying this report is a schedule listing all projects and funding progress through the end of fiscal year 2022.
