# **New Business**

Robin reviewed the following:

- 2013 Child Safety & Injury Prevention Symposium on August 8<sup>th</sup>, 8:00 Noon at Rosen Centre Hotel in Orlando. Topics will cover: national perspective on child injury & prevention, crimes against children, bullying, gun safety, drowning prevention and hyperthermia awareness. Robin indicated she has 3 seats available at no charge if anyone is interested in attending, otherwise, it is \$25 per person.
- Bicycle Training Opportunity on October 14<sup>th</sup>, Seminole County Public Safety Bldg. located at 150 Bush Blvd in Sanford. All day class (8:30 4:30) will include bike helmet fitting training, community elementary bicycle education training, bike rodeo training. Class is free and is limited to 20. - Poster and pamphlets on drowning prevention are available for utilization in kiosks at malls, front office pamphlet areas, etc.
- Child Passenger Safety Training looking at late September or early October and will forward information.

Hyperthermia display unit is available. There have been 23 child deaths this year associated
with heat/cars which is a record high number. Believes there will be a Hyperthermia Awareness
Campaign but would like to get the unit out if anyone is interested.

SR 434 and Markham Woods Road – DOT has not approved recommendation as yet – Joe advised he will find out a status.

There was a brief discussion regarding park being built and possible placement of 3 way stop signs at Milwee and Church in Longwood – RSA Team to look at.

Red Bug and Chatham Pines Circle – request for signal. Mike believes a study was done recently and will discuss this request with Mark Bevis.

JoJo reviewed their programs for the upcoming year and noted Bike Safety Week, May  $5^{th} - 10^{th}$  with a large safety event day covering multiple items on Saturday, May  $11^{th}$ . Thirteen (13) Safety Zone Campaigns are scheduled, School Safety Zone Awareness is October  $7^{th} - 11^{th}$ , and, they have a new pilot program titled Safety Squad.

Jim Martin advised they conducted 83 Operation Lifesaver trainings in June. Areas of concern brought forth in Seminole County: Lake Mary and Country Club, 17-92 – south side of Barn, and 18<sup>th</sup> and Southwest St. Will begin same training on August 6<sup>th</sup> for Seminole County Public School Drivers and thanked JoJo for her assistance with setting this up. Cab cars will be arriving for ER training for law enforcement and first responders. Ballard and 436 at Station Street will be closed Saturday, 2 -10 a.m. Advised he has an ongoing question that he is still investigating in regards to Lynx not opening their doors at RR tracks.

Discussion regarding National night out events – it was noted Longwood, SCSO and Altamonte would have events.
