Robin Butler called the meeting to order at 8:35 am and requested review of minutes from August 27th meeting. Minutes were reviewed, with motion to approve by Dave Andrews and second by Mark DiBona.

**Old Business:**

**New Business**

- SunRail distributed handout on SunRail Safety. It was indicated they are putting together a PSA video and need law enforcement/safety person involved and are looking for volunteers. They are also looking for enforcement days – on day per month and will need to coordinate with someone. Service is slated to begin March 2014. In response to questions, it was advised there are no law enforcement on SunRail trains and the parking lot is owned by FDOT.
- UCF advised the football game at noon on October 28<sup>th</sup> is sold out. Tailgating begins at 7 a.m. and they are expecting 60,000 to 80,000 attendees.
