Announcements

JoJo indicated law enforcement has had a greater presence in school activities and it has made a big difference. JoJo also indicated they have distributed over 350 helmets.

Sheryl noted June 1st - 7th is Train Safety week. SO noted they have been doing enforcement with Sun Rail. There was a discussion regarding striping of a "box of death" at crossings for more awareness of track safety. Lake Mary noted they did operation for 2 weeks after opening

Colleen suggested that someone from Sun Rail come to next meeting. Sheryl further noted next week would be a good week to have press release, with Robin indicating she would look for one. Robin suggested strong enforcement for train safety week.
