Commissioner Henley comments, concerns and questions were as follows:

- Explained a little about the 5 points study, how would that affect the museum. He said it would not impact the museum. Discussion followed.
- The Museum will not be moved, it is a foundation. The Museum's Long Range Plan has been on the drawing board for 5 years.
- The Farmer's Market marker dedication had been delayed. Commissioner Henley told the commission that the county built The flea market type of building that is not being used.
- The master plan for the museum has always included the same foot print for the amount of space within the museum complex. The two story building is a common way to achieve the educational vision of the museum.
- Karen explained all the many projects that staff has been working on; Time Union newspaper, web history game, puzzles, web access, Golden Rule, summer programs, marriage license, Seminole County Public School, Research projects.
- Commissioner Henley requested a wish list for the museum from Karen to be sent to his office as soon as possible.
- Discussion ensued on Altamonte and Oviedo Library to be used as Museums for Altamonte and Oviedo Historical Societies. Commissioner Henley gave his view points on the subject.
