Commissioner Van Der Weide said the Board has not forgotten the museum but apologized for not funding the museum this year and said they were automatically going back into the grant process and hopefully will be successful in the future.

Comments and concerns that were proposed to Commissioner Van Der Weide were as follows:

1. Not closing the museum one day at week. How does closing the Museum save money? How much does it save? Who determines the costs? Where did they get their figures? Who are they?

- 2. The Historical Board understands the crunches for budget but the part-time person fills the needs to keep the museum open that sixth day and meets the needs of the community. To close the museum would be taking two steps backwards. It is one person compared to hundreds in the library.
- 3. Commission Van Der Weide said the Historical Commission can voice their opinion at the final public budget hearing on next Tuesday at 7:00 p.m.
- 4. Commissioner Van Der Weide said that if the tax referendum is passed in January, the county might have to lay off people. If it weren't for the 3% Save Your Homes, the taxes here would be outrageous. People are moving out of the county. The people in Seminole County are in for a rude awakening.

The Historical Commission proceeded with their scheduled work session and discussed many items including the following:

- 1. The Museum's budget
- 2. Are the museum's bills getting paid in a timely fashion?
- 3. Is the Museum's coordinator in charge of the Museum's budget?
- 4. The closing of the one day of the Museum
- 5. Who will represent the museum at the budget hearing?
- 6. Would the museum be better served under another department? such as Leisure Services or Tourism?
- 7. Sending a letter of concerns to each County Commissioner which has been done in the past.
- 8. Getting correct figures for the museum's electric bills, etc. to help determine the costs of closing.
- 9. E-mail letter to all for critique comments.

Society Report: Antique appraisal Fair at Lake Mary Community Center on Sept. 15, 2007 raised \$300.00 toward the building fund.
