

The County's Budget

The Fiscal Year (FY) 2009/2010 adopted budget for Seminole County totals \$885 million, a decrease of \$102 million from the FY 2008/2009 budget. The budget includes \$158 million of cash brought forward for ongoing capital projects funded by special revenue sources. Seminole County has one of the lowest millage (property tax) levies



compared to surrounding counties, ensuring you get the best value for your tax dollars. The base budget, defined as estimated incoming annual revenue, is \$457 million.

A conservative and proactive financial management approach has been taken to ensure the County continues to maintain a strong financial position. The financial challenges that lie ahead are being managed through a long-term fiscal planning perspective. By continued focus on our service delivery and business practices, critical services can continue in a



stable tax environment. Above is a breakdown of the County's spending plan totaling \$608 million including infrastructure projects.

How Far We Have Come in the Last Decade

Seminole County Major Milestones from 2008 - 1999

- Fire-EMS Training Center opened.
- Official opening of the Gas to Energy Plant at the Seminole County Landfill.
- Reconstructed Fire Station 13 opened.
- Tropical Storm Fay hit Seminole County causing substantial flooding.
- Winter Springs Fire Department merged with Seminole County Fire Department.

2007

• Seminole County officially opened two pedestrian bridges over Lake Mary Boulevard to maintain the safety of school children and trail users.

2006

- County launched Adopt-A-River program.
- Seminole County Government received a rating upgrade by Standard & Poor's Ratings Services (S&P) from AA- to AA.
- East Lake Mary Boulevard extension to SR 415 officially opened.



2005

· County adopted water conservation measures including watering restrictions.

2004

- Dedication of expanded Seminole County Juvenile Justice Center.
- In August and September, Seminole County Government responded to three hurricanes, Charley, Frances and Jeanne that affected the county's residents and



- The five-story, 223,000 square ft. Seminole County Criminal Justice Center opened with 10 new courtrooms.
- Environmental Services acquired 7 new water service areas formerly owned by Florida Water Services.

2003

- Agricultural Exhibit Building addition at the Museum of Seminole County
- Official opening of the I-4 Trail Overpass Bridge, a 3.5 million dollar, 373-foot long, cable-stayed suspension bridge over Interstate 4.
- Seminole County started collecting old electronics for recycling as part of the Household Hazardous Waste Program (HHW).

2002

- A major section (9.7 miles) of the 12 mile Seminole-Wekiva Trail was completed.
- Altamonte Springs Fire Department completed merge with Seminole County
- Construction of the Greene Way (SR 417) "missing link" from US 17-92 to Interstate 4 is completed.

- Seminole County voters approved the continuation of the 1 Cent Local Option Sales Tax to fund roads, sidewalks, trail and school improvements.
- Kewannee Park opened.

2000

- First phase of the Seminole Wekiva Trail completed.
- Two new neighborhood parks (Roseland and Jamestown) opened.
- Sanford Orlando International Airport established foreign trade zone to attract business.

1999

- Construction of new fire station near UCF (partnership with Orange County and UCF) completed.
- Seminole County Emergency Operations Center (EOC) created to provide centralized and expedited emergency response to disasters.

Effective & Efficient Government

2.4 million visits

The natural place to play - Over 2.4 million visits were experienced on 60 miles of paved trails, 8 wilderness areas open to the public and at 24 parks managed by Seminole County Leisure Services. Only 3.7 miles of paved trails and 4 wilderness areas open to the public existed in 1999.

\$96 million | Quick and safe travel - Public Works is responsible for 900 miles of road, 45 bridges, 530 retention ponds, 300 miles of culverts, 125 for roads & miles of canals, 780 miles of sidewalk and 225 miles of fiber optic cable. In 2009, 60 major and minor road and sidewalk projects were completed on 16 miles for \$96 million.

Reducing traffic wait time - 360 traffic signals can now be remotely monitored with County ground equipment, reducing response time to correct signal malfunctions and trouble call notifications.

5 libraries with more than 2 million books

Check it out! - In 2009 Seminole County's five Public Libraries circulated 2.4 million books, had 270,255 registered library patrons, was visited 1,161,244 times and library staff answered 1,235,284 information questions. In comparison in 1999/2000, the libraries only had 220,252 registered library patrons.



271,081 monthly web hits

County government via the web - The Seminole County web site had an average of 271,081 visitors each month last year including "Live" board meetings (accessed 79,718 times). The average monthly number of visitors to the Internet web site for 1999 was 34,571. Want to pay your water bill online? No problem. During 2009, Water and Wastewater processed 44,235 credit card payments collecting a total of \$4,858,860.


\$299,342 in savings

Reducing expenses - Implementation of the construction Sales Tax Savings program where the County does a direct purchase for construction materials, mitigates allowable sales tax resulting in a reduction of over \$299,342 in construction expenses.

Responding to your emergency - The Emergency Communications Center handled 63,000 calls for 911 service for Fire/EMS/Rescue last year. 45% of those calls were from cell phones. New software pinpoints caller location including those with cell phones.

Addressing Growth & the Environment

\$2.9 million energy grant

Stimulating sustainability - Seminole County was among the first 10 local governments in the nation to receive an award through the Energy Efficiency and Conservation Block Grant Program. The award totals \$2,925,100 to support countywide sustainability efforts.



6,662 acres preserved

Preserving the environment and conserving corridors - Seminole County managed 6,662 acres of land preserved for education, habitat preservation and passive recreation and 20 miles of wilderness trails — compared to 5,052 acres of preserved land and 14 miles of wilderness trails in 1999.

Trash to energy - During fiscal year 2009, the Gas-To-Energy Facility at the Osceola Road Landfill combusted over 642 million standard cubic feet of landfill gas to produce nearly 31 million KWH of electricity (enough power for about 1,900 homes.)





16,000 tons of recyclables

Keeping the County clean - Solid Waste Management Division collected 296,000 tons of garbage, 52,000 tons of yard waste, 16,000 tons of recyclables, 6,200 tons of construction and demolition debris, 510 tons of white goods-appliances and 520 tons of waste tires. Garbage is 10% higher and recyclables are 170% higher than the amounts collected in 1999.



708,198 lbs of hazardous waste collected

Minimizing pollution - Household Hazardous Waste Program collected and managed 708,198 pounds of hazardous waste, 424,972 pounds of old electronics, 12,160 pounds of medical sharps (needles) and 7,874 gallons of used oil from more than 19,500 residential customers. Household hazardous waste saw an increase of 417% and sharps collection has increased 170% since 1999.

Saving 820,000 gallons of water per day

Meeting the needs of utility customers - Seminole County's Water Section produced 6,351,365,000 gallons of potable water for 38,110 customers (17,401,000 gallons per day). The Seminole County Wastewater Section was responsible for 3,531,740,000 gallons of wastewater treated (9,767,000 gallons per day). Conserving the water supply - In 2009, the County expanded the reclaimed water system beyond commercial customers to 500 residential customers saving a total of 820,000 gallons of potable water per day.





\$517 million in permitted construction

Keeping up with growth - Planning and Development handled 10,032 building permits worth \$517 million and facilitated 57 land use changes or zoning permits.

9% carbon footprint reduction

Saving energy in County buildings - Energy efficiency measures in lighting, heating and air conditioning in County buildings has reduced our carbon footprint by 9% since 2006 and resulted in \$392,107 in savings to taxpayers. Reducing fuel usage - The fleet fueling operations supplied 236,778 gallons of unleaded fuel and 629,470 gallons of diesel fuel, reducing usage by 7.33% from the previous year.





Social & Economic Opportunities

45,615 individuals taught

Solutions for your life - The Extension Service held 467 group class events in gardening, finances, or food preparation reaching 45,615 individuals.



3,873 claims filed

Paying back those who served our country - In 2009, 8,408 veterans were helped resulting in 3,873 claims filed



11,000 service hours

Diverting youth from crime - 11,000 community service hours were completed by the 1,100 teens that went through community arbitration and the 300 teens judged by their peers in teen court.



902 jobs projected Growing jobs - Economic Development brought 11 projects to the County which is projected to produce 902 new/saved medical, manufacturing, aviation, distribution, financial and technology jobs over the next 3 years with an annual average wage of \$55,416 and \$22.8 million in capital investment.

\$10 million economic impact

Attracting visitors - Seminole County hosted 45+ weekend tournaments and events that utilized Seminole County parks and facilities generating approximately 18,000 room nights and yielded a direct economic impact of over \$10,000,000 for Seminole County hotels and local community.



2 new hotels

More places to stay - Two new hotels opened in Lake Mary bringing the total hotel rooms in Seminole County to 5,495. In 1999, Seminole County only had 3,601 hotel rooms.

261,619 zoo visitors

Our main attraction - Central Florida Zoo attendance increased over the previous year to 261,619. In 1999, the Zoo had 200,848 visitors.



\$2.3 million for 17-92

Developing Seminole County's retail corridor - The 17-92 Community Redevelopment Area (CRA) approved 17 projects totaling \$2,279,470 in capital investment that will improve the corridor by removing blight.

1,674 households assisted

A lifeboat for those in need -1,674 households were assisted in the amount of \$790,000 with medical, utility, childcare and eviction prevention payments by Emergency Financial Assistance in 2009.

53,777 volunteer hours

Volunteers make a difference - Volunteer Hours in Animal Services: 12,500, Extension Services Master Gardeners and 4H: 20,979, Leisure Services: 14,000, 53.5 miles of river adopted by citizens, 43.68 miles of roads cleaned, 1,474 active Watershed Action Volunteers (WAV) contributed 6,298 volunteer hours.



\$10.2 million in funds

Taking advantage of Federal dollars - The American Recovery and Reinvestment Act of 2009 provided funding of \$10,250,000 for 11 projects that included transportation improvements, community services and public safety enhancements.

\$11,000 in contributions

Employees give back - From charity walks to canned food drives and donating toys at Christmas, Seminole County employees helped make the community a better place with 108 volunteer hours and \$11,000 in contributions.
