- 2004 was an unusual and unpredictable hurricane season
- 3 major storms affected Central Florida





Hurricane Issues

- Trees down
- Flooding
- Building damage
- Communicating to residents
- Power outages
- Traffic signals out
- Roadways blocked

Hurricane Debris

- More than 300 trucks on roadways
- Solid Waste Management facilities open 7 days
- Half a million tons of debris generated by storms – TEN YEARS worth
- Residential pick up completed in December
- Debris taken to landfill or burned

Total costs to the County for Hurricanes Charley, Frances and Jeanne are:

- \$54.9 million
- County's responsibility estimated to be \$6.5 million

- Average wage of \$44,000



Debt Service as % of Total Expenditures



Library Status and Trends

- Library created in 1978
- Five libraries constructed by 1988
- Population increased 41%
- No facility expansion during the last 17 years
- Current sites allow limited expansion
- Libraries heavily used.
 25% of reference questions directly relate to Seminole County School curriculum

Navigating our Way







Library Recommendations

- Additional libraries
- Open 7 days
- Multipurpose conference rooms
- In-depth reference and circulating collections
- Audiovisual services
- Computer rooms/laboratories
- Cost estimates for both new construction and renovation of current libraries \$53 million

Navigating our Way





John E. Polk Facility



- Built in 1981
- In 1987 480 beds added at \$13.6 million
- Population has exceeded number of beds available
- Average daily population 960

Navigating our Way

John E. Polk Facility

- Space assessment found projected inmate population of 1,150
- Additional 1,152 beds will provide space through the year 2012
- Phased approach recommended
- Initial phase of 640 beds will cost \$42 million
- Funding needs to be identified





Subdivision Infrastructure





Navigating our Way

- Areas of County built prior to 1945 have limited public infrastructure
- Plats recorded prior to State stormwater regulations
- Infrastructure in these areas exceeding designed life span

Subdivision Infrastructure

- Long term needs of infrastructure need to be addressed prior to 2008
- BCC will address initiatives to hasten infrastructure rehabilitation process

Floridan Aquifer major supply

- Residents use 20 MGD
- Projected needs in 2020 are 30 MGD (an increase of 50%)

 SJRWMD permits and regulates use. They caution that additional withdrawals will cause harm to the Aquifer and environment

Water Supply

• SJRWMD encourages conservation and alternative water sources

NW Reclaimed Water project

- Reclaimed water will be used to irrigate lawns
- Project will save 900,000 gallons of water each day
- Seminole County participates in water-wise landscaping, irrigation audits and Artesian Well-plugging Programs









Water Supply





• Alternative sources cost additional dollars

- Seminole County is a leader, forming partnerships to explore other sources and ways to fund these alternatives
- Board to identify additional funding or potential bond issue

Navigating our Way



- Land use changes affect the County in many ways:
 - School quality
 - Economic diversification
 - Fiscal health
- The County and School Board are working together to analyze the affects of growth
- Board commissioned study to determine the appropriate balance of land uses in preparation for build-out:
 - Fiscal impact analysis model (FIAM)
 - Economic sustainability






Unfunded Mandates

- Reduction in revenue sharing has impacted Seminole - \$23 million since inception
- Elimination of recycling grants while recycling mandates continue -\$1.5 million since inception
- Medicaid contribution \$600,000 since inception
- HB I I 3A Court System cost shift by State to Seminole County -\$700,000 annually

Navigating our Way





- Department of Juvenile Justice (DJJ) will cost Seminole \$ 2.1 million annually
- No County oversight in Juvenile Justice operations
- Impacts local property owners with State obligation
- Legislation will be addressed again in upcoming session





Board Options for the Future

- Do nothing
- Increase Impact Fees
- Increase other User Fees
- Increase Millage
- Bond Referendums


