# FY 2019-2020 ONE-YEAR ACTION PLAN

Community Development Block Grant HOME Investment Partnerships Emergency Solutions Grants The Substantial Amendment adds \$2,006,356 in CDBG-CV3 grants that became available through the CARES ACT in a supplemental allocation from HUD. The funds will be used to prepare for, prevent and respond to Covid-19 impacts in Seminole County. In addition, Amendment #4 will reallocate CDBG-CV1 funds to other eligible activities. The Economic Development strategy will cancelled due to Seminole County's receipt of CARES ACT funds from the US Treasury. The funds were used to provide assistance to area businesses and would have been a duplicative benefit.

### 1. Introduction

Substantial Amendment #4 of the FY 2019-2020 Action Plan programs a supplemental (third round) of CDBG-CV funds. The funds became available through the CARES Act. The amendment will program \$2,006,356 in CDBG-CV-3 funds. Amendment#4 also reallocates CDBG-CV-1 funds in the amount of \$1,238,297 due to the cancellation of the Economic Development strategy. The funds will be reallocated in order to recover eligible non-duplicative expenses Seminole County incurred to prepare for, respond or prevent the spread of COVID-19 from February 2020 to present. The CDBG-CV3 funds may also be used to provide mortgage assistance to eligible low income households to prevent foreclosure and displacement.

Substantial Amendment #3 of the FY 2019-2020 Action plan programs a supplemental (second round) of ESG-CV2 funds. The funds became available through the Coronavirus Aid, Relief, and Economic Security Act (CARES) The substantial amendment programs \$1,183,769 in ESG-CV2 funds. Amendment#3 also reallocates a portion of the first round of ESG-CV1 dollars to allow for more funds to be used for additional costs and staffing needed for the Homeless Management Information System (HMIS). The system is required for homeless programs and has to be expanded to track ESG-CV clients. Amendment #3 was approved by the Board of County Commissioners in November 2020.

Substantial Amendment#2 of the FY 2019-2020 Action Plan programs HUD funds that are earmarked to provide assistance to individuals and households impacted by the COVID-19 health crisis. The funds became available through the Coronavirus Aid, Relief, and Economic Security Act (CARES). The substantial amendment programs \$1,238,297 in CDBG-CV and \$591,952 in ESG-CV funds. In addition, the substantial amendment reallocates \$224,743 of FY 2019/2020 funds to provide public services in response to COVID-19. The reallocation of the 2019/2020 CDBG dollars occurred as a result of the

cancellation of the Acquisition, Rehabilitation, Resale project. Amendment #2 was approved by the Board of County Commissioners in May 2020 and Approved by HUD in June 2020.

Substantial Amendment #1 amended the Acquisition, Rehabilitation and Rental project and decrease the funds to \$224,743. The amendment also allocated funding for Homeowner Rehabilitation (\$300,000.00) and Contingency/Cost Overrun (\$70,000.00). Amendment #1 was approved by the Board of County Commissioners in February 2020 and submitted to HUD for approval in April 2020.

Seminole County is an entitlement community that receives annual allocations of funding from the US Department of Housing and Urban Development (HUD). As such, Seminole County prepares strategic and annual action plans to identify the community needs and priorities for use of Federal grants aimed to improve communities throughout Seminole County. The 2015-2019 Consolidated Plan was approved July 28, 2015, and identified high priority needs related to providing affordable housing opportunities, providing supportive services to homeless and other at-risk populations, improving overall health, providing infrastructure improvements such as water lines and street lighting, also offering housing repairs, rental assistance, and home purchase assistance programs.

Annual Action Plans are developed to outline the programs and projects that will be funded and implemented each year to help meet the goals identified within the Five Year Consolidated Plan (Strategic Plan). Annual accomplishments and grant expenditures are reported in an annual performance report.

The FY 2019-2020 One Year Plan identifies projects and programs that will be funded by the Community Development Block Grant (CDBG), HOME Investment Partnership (HOME), and Emergency Solutions Grants (ESG). Seminole County has been allocated \$1,953,684 in CDBG funds, \$699,228 in HOME funds, and \$ 161,772 in ESG funds. The FY 2019-2020 Action Plan was prepared with input from the public in accordance with federal regulations. The plan seeks to implement the goals and objectives of the Consolidated Plan to benefit low and moderate-income households and individuals in Seminole County through provision of various improvements and services.

Substantial Amendment#2 of FY 2019/2020 Action Plan programs supplemental funds that became available through the CARES Act. Seminole County was allocated \$1,238,297 in CDBG-CV and \$591,952 in ESG-CV dollars to respond to the COVID-19 health crisis. Emphasis will be placed on job retention for low income workers, support of microbusinesses, various services for the homeless (rapid- rehousing, homelessness prevention, shelter operations, and street outreach) as well as, public services to respond to persons impacted by COVID-19. Economic development, homeless services and public services are high priority needs previously identified in the 2015-2019 Consolidated Plan.

Substantial Amendment #3 of the FY 2019/2020 Action Plan programs supplemental ESG funds that became available in a second allocation of CARES Act dollars. Seminole County was allocated \$1,183,769

in ESG-CV2 funds. These funds will be used to continue providing much needed services for the homeless (rapid rehousing, homeless prevention, shelter operations, and street outreach) in response to the COVID-19 Health Crisis. Homeless populations (in shelter and unsheltered) are at risk populations for contracting COVID-19. Funds will be used to respond to COVID-19 and prevent the spread of the virus.

Substantial Amendment #4 of the FY 2019-2020 Action Plan programs a supplemental (third round) of CDBG-CV funds. The funds became available through the CARES Act. ### 3. Evaluation of past performance

Seminole County used CDBG, HOME and ESG funds to address the high priority community development needs outlined in the Five-Year Consolidated Plan. Affordable Housing is the highest priority need identified in this plan, and accomplishments which improved the affordability were realized through the Homeowner Rehabilitation program, which assisted 4 households with improvements using CDBG and HOME funding. The Immediate Needs program assisted 36 households with necessary repairs; and affordable rental housing was provided to 20 households through the Tenant-Based Rental Assistance program. Additionally, two households were assisted with becoming homeowners through the Purchase Assistance program.

Four public facility improvement projects were completed during FY 2017-2018. They include Phase 2 of the Midway Waterline Improvements, the Bookertown Park Facility Improvements, and the Inspire Public Facility improvements. Approximately \$816,781 was drawn down in program year 2017 for the Midway project. Phase II construction was completed in June, 2018.

**Annual Action Plan** 

Public Services was identified as a high priority need, and services provided using CDBG funds resulted in 53 individuals receiving access to necessary dental care, 38 families received assistance with child care. Mental health services were provided to 54 persons, and 99 elderly persons were able to participate in a senior services program. Two activities for the homeless were completed to improve coordination and address homeless needs specific to the Seminole County community. ESG funds were used to support shelter operations for three emergency shelters operating within Seminole County.

### 4. Summary of Citizen Participation Process and consultation process

HUD requires input from the public regarding proposed projects and initiatives that result from the Federal funds entrusted to Seminole County. Public comment can be obtained in a variety of ways. The public is welcome to call, email, write, meet in person, and participate in public meetings/ forums. All notifications regarding the FY 2019-2020 One-Year Action Plan are published in the Orlando Sentinel, a newspaper of general circulation, as required by Federal regulations. Seminole County also hosts public meetings and gathers feedback from stakeholders at various stages of the planning process. A public hearing is held prior to the publication of the draft action plan. The public is also given a 30-day comment period to offer their feedback after the draft action plan has been published. Additionally, a summary advertisement is published in the newspaper and county website. Hard copies are made available at the Community Services Offices for persons who have limited access to a computer or those who require in depth explanations of our programs and requirements.

Seminole County uses a request for application process to allow non-profit organizations to partner to implement programs that are funded through CDBG public services, HOME, and the Emergency Solutions Grant. Agencies were about the available funding and participated in technical assistance workshops prior to the submittal of grant applications. Proposals were received and reviewed by staff for eligibility determination after receipt, and reviewed and ranked by the Application Review Team.

Additionally, the draft 2019-2020 Action Plan was presented to the Seminole County Board of County Commissioners on July 23, 2019. The public was given an opportunity to comment prior to approval by the Commissioners.

A summary of Amendment# 2 of the FY 2019/2020 Action Plan was posted on the county website and published in the Orlando Sentinel. The comment period began May 1, 2020, and concluded May 8, 2020, in accordance with HUD's expedited public notification and public comment requirements to quickly receive and implement Cares Act funding. The public notice and summary were posted on the County website on April 27, 2020. The amendment was presented to the Board of County Commissioners at their May 12, 2020 meeting.

A summary of Amendment #3 of the FY 2019/2020 Action Plan was posted on the County website and published in the Orlando Sentinel. The public comment period began October 25, 2020, and concluded

November 6, 2020, in accordance with HUD's expedited public notification and public comment requirements to receive CARES ACT funding. The public notice/summary was posted on the County Website October 19, 2020. Amendment #3 was presented to the Board of County Commissioners at their November 10, 2020 meeting.

A summary of Amendment #4 of the FY 2019/2020 Action Plan was posted on the County website and published in the Orlando Sentinel. The public comment period began March , 2021, and concluded March , 2021, in accordance with HUD's expedited public notification and public comment requirements to receive CARES ACT funding. The public notice/summary was posted on the County Website \_\_\_\_, 2021. Amendment #4 was presented to the Board of County Commissioners at their March , 2021, meeting.

### 1. Introduction

To increase coordination with local and state agencies that were integral to the completion of the 2015-2019 Consolidated Plan, the Seminole County Community Services Department will implement the following strategies to achieve the goals and objectives outlined in the Consolidated Plan and strengthen partnerships with these agencies to ensure successful implementation of all federally funded activities

# Provide a concise summary of the jurisdiction's activities to enhance coordination between public and assisted housing providers and private and governmental health, mental health and service agencies (91.215(I))

The Seminole County Community Services Department continues to enhance its partnership with local public and nonprofit providers. These partnership ensures public access to a wide range of housing, health and human service programs in Seminole County. Community Services staff conducts outreach, education, training and technical assistance to enhance coordination with public and private housing and supportive service providers. Staff serves on numerous committees and task force both in Seminole County and the Tri-County Region including the Central Florida 507 Continuum of Care which is responsible for addressing homelessness in Central Florida; Seminole County Alliance, a public Body governed by State statue to monitor services and assess and advocate on behalf of at risk children and families in Seminole County. Seminole County also continues to partner with area housing authorities and offer support in various planning and other improvements planned for Housing Authority properties. Community Services staff continued to participate in stakeholders meetings for the Orlando and Sanford Housing Authority Choice Neighborhoods Initiative (CNI) which has completed the planning phase and is preparing to apply for CNI Implementation Funding. Community Services staff continue to collaborate with Seminole County Housing Authority to address homelessness among families with Children who are literally homeless in Seminole County. Community Services, Office of Community Partnership and Quality Assurance monitors all Federal, State and Local funds administered by the County Community Services Department. Training and Technical Assistance are integral components to ensure compliance and quality of services.

# Describe coordination with the Continuum of Care and efforts to address the needs of homeless persons (particularly chronically homeless individuals and families, families with children, veterans, and unaccompanied youth) and persons at risk of homelessness.

HSN receives direct funding through the Department of Children and Families (DCF) ESG program annually for the operation of programs that provide direct housing and supportive services to the homeless population in Seminole County. The Seminole County Community Services Department will continue partnership with the HSN to oversee the implementation of Rapid-Rehousing services. The County currently oversees four Rapid Re-Housing Programs (RRH) for families through the following funding sources: ESG, CoC, State Housing Initiatives Partnership (SHIP), and general revenue funds. Additionally, Community Services operates an internal Permanent Supportive Housing (PSH) for 46 chronically homeless households. There is also an active partnership with the Seminole County Housing Authority which provided over thirty Section 8 vouchers for literally homeless families identified by the County and Street Outreach-HOPE Team.

The Seminole County Taskforce has created committees to address the barriers and impediments to housing families and individuals comprised of community partners to help provide solutions. In addition, the Seminole Action Board (SAB) was established in 2016 and consists of prominent local business leaders in the Community as well as the County Manager, Seminole County Commissioner Chairman, and members of the Central Florida Commission on Homelessness. SAB was created to address the identified gaps in homeless services within Seminole County.

# Describe consultation with the Continuum(s) of Care that serves the jurisdiction's area in determining how to allocate ESG funds, develop performance standards for and evaluate outcomes of projects and activities assisted by ESG funds, and develop funding, policies and procedures for the operation and administration of HMIS

The Homeless Services Network, the lead agency of the Continuum of Care (Coe) is responsible for the award of State ESG funding through their competitive application process. The lead agency is also responsible for maintaining the HMIS and implementing the Coordinated Entry System. Seminole County participates in weekly coordinated entry system referral meetings to ensure that Seminole County homeless residents are prioritized for housing placements. Seminole County staff is also a member of the HMIS advisory committee to assist in the development of HMIS standards and ensure Seminole County is in compliance with CoC performance measures. Additionally, Seminole County, along with other jurisdictions in the region met specifically regarding the ESG funded program policies to ensure both the Continuum of Care and jurisdictions policies and priorities were aligned.

The public is also given a 30-day comment period to offer their feedback after the draft action plan has been published. Seminole County uses a request for proposal process to allow non-profit organizations to partner to implement programs that are funded through CDBG public services, HOME, and the Emergency Solutions Grant. Agencies were notified in March 2019 about the available funding. Proposals were received and reviewed by staff for eligibility, and were also reviewed and ranked by the Application Review Team on May 7, 2019.

Additionally the draft FY 2019-2020 Action Plan was presented to the Seminole County Board of County Commissioners on July 23, 2019. The public was given an opportunity to comment prior to approval by the Commissioners.

Prior to the publication of the One Year Action Plan, Seminole County staff convened its Affordable Housing Advisory Committee (AHAC) to identify and develop strategies to address the affordable housing needs in the region. Based on the feedback, Seminole County sought to continue its focus on providing resources to mitigate various facets of housing along with public services and public facility improvements in the 2019-2020 Action Plan.

### Introduction

In 2019, Seminole County expects to receive an annual allocation of \$1,953,684 for the CDBG Program along with \$3,510 in program income . Of the total funding allocation \$390,736 will be allocated for Administration activities, \$517,796 will be allocated for Public Service Activities; \$50,000 will be allocated for project delivery costs for Housing; \$53,510 will be allocated for demolition; \$300,000 will be allocated for housing rehabilitation; \$295,000 will be allocated for infrastructure improvements; and \$350,152 will be allocated for Public Facility Improvements.

Seminole County also expects to receive an annual allocation of **\$699,228** for the HOME program. Of the total funding allocation, **\$69,923 will** be allocated for program Administration activities, **\$104,884** will be allocated for Affordable Homeownership activities to be implemented by a County authorized Community Housing Development Organization (CHOO); **\$134,421 will** be used to provide purchase assistance to increase homeownership opportunities; **\$300,000** will be allocated to provide Tenant-Based Rental Assistance to assist elderly and persons with disabilities obtain/maintain affordable housing; and **\$90,000** will be allocated toward the construction of an affordable housing rental project by sub-recipient partner agency.

Seminole County will receive an annual allocation of **\$161,772** for the ESG program. Of the total annual allocation, **\$12,133** will be allocated to Administration activities to include 12 HMIS licenses; **\$34,139** will be allocated for emergency housing placements; **\$49,500** will be allocated to a rapid re-housing activity, and **\$66,000** will be allocated toward Shelter Operation and Maintenance for homeless shelter activities.

Seminole County is also slated to receive CDBG-C V funds in the amount \$1,238,297 and ESG-CV funds in the amount of \$ 591,952. The funds were made available through the CARES Act to prepare for, prevent and respond to Coronavirus (Covid-19). Seminole County received a second allocation of ESG (ESG-CV2) funds through the CARES Act in the amount of \$1,183,769 to prepare for, prevent and respond to Coronavirus

(Covid-19). Seminole County received a supplemental allocation of CDBG-CV funds (CDBG-CV3) in the amount of \$2,006,

## Explain how federal funds will leverage those additional resources (private, state and local funds), including a description of how matching requirements will be satisfied

Seminole County continues to leverage federal funds with applicable state and local fund to increase impact within the community. Although federal, state, private, and local grant program funds and activities operate according to their own guidelines and requirements, they are frequently combined to provide a greater level of funding for housing and community development needs. For example, federal CDBG funds can be leveraged with State Housing Initiatives Partnership (SHIP) program funds to meet affordable housing needs. The HOME Investment Partnership program funds can also be combined with SHIP to provide assistance for qualified low- and moderate-income first-time homebuyers in the form of down payment, principal reduction, and closing cost assistance. **Seminole County received approximately \$1.9 million in SHIP funds for State FY 2017-2019.** Each allocation of SHIP funds has a three -year expenditure deadline. Additionally, County funds are granted to area non-profits to provide a variety of essential and supportive services within the community through the Community Service Agency Partnership Program (CSA). CSA Program grants are made available annually. In FY 2018-2019 \$856,604 in county general funds were awarded to non-profit organizations. Some of the recipients of the local funding also provide CDBG funded public services or ESG funded homeless services. SHIP Funds provide match for the HOME and State ESG programs. Seminole County meet the required ESG match requirements by receiving cash and in-kind match from non-profit homeless service providers who implement grant funded programs and activities.

## If appropriate, describe publically owned land or property located within the jurisdiction that may be used to address the needs identified in the plan

Seminole County has designated affordable housing lots throughout the County that may be used as leverage for affordable housing projects funded with federal funds when necessary. As of June 30 2019, Seminole County has 15 county-owned lots and/or properties that can be leveraged and used to meet affordable housing needs. Non-profit organizations apply for these available lots with the condition they construct affordable housing units for resale or rental to low income households. The list is maintained by Seminole County Community Services.

## Projects

### AP-35 Projects – 91.220(d) Introduction

For FY 2019-2020, Seminole County has selected three public facility improvements to promote and provide secure enhancements and building renovations for greater efficiency and to address safety concerns. Two of the facilities provide services for the homeless including those with special health care needs. The other facility improvement project serves special needs population including those with mental health and substance abuse disorders.

Seminole County is allocating additional funds to address the need for affordable housing. Funds will be used to acquire and rehabilitate units for affordable rentals. In addressing the critical need of making homeownership affordable, the County will continue to provide purchase assistance to help defray the closing costs for homeowners who have the resources to make monthly mortgage payments but do not have the ability to meet the down payment requirements to become homeowners. The County will also continue its partnership with Habitat for Humanity in leveraging federal funds to construct and or rehabilitate three (3) housing units for homeownership by low-income households, using HOME program funds.

## Describe the reasons for allocation priorities and any obstacles to addressing underserved needs

Seminole County will continue to address the priorities identified in the Community Services Strategic Plan which is consistent and congruent with the HUD 5-Year Consolidated Plan. While the intent of the acquisition, rehabilitation resale project was to increase the availability of affordable housing, a greater need to provide housing repairs for low/mod households emerged requiring the reallocation of funds in substantial amendment #1. The COVID-19 health crisis emerged during the FY 2019/2020 program year, resulting in the need to cancel the acquisition, rehabilitation resale project and reallocate \$224,743 for public services in response to COVID-19. The CARES Act lifted the 15% cap on public services to help address COVID-19 needs. Seminole County received supplemental allocations of CDBG and ESG funds to prepare for, respond to and prevent the spread of COVID-19. Additional substantial amendments were necessary to program the additional funds.

#### Rationale for the priorities for allocating investments geographically

During FY 2019-2020, investments are allocated to countywide activities and not a geographic location. During the planning process for the 2019-2020 One Year Action Plan, there were no projects identified within the Midway and Bookertown target areas. Activities will meet national objectives by benefiting low and moderate-income persons through income qualification of activities, and through activities that exclusively benefit persons in a category that are presumed to be low income.

#### Discussion

2019-2020 HUD-program funding allocations will be used countywide based on the level of need. Beneficiaries will be selected based on criteria determined by the Seminole County Community Services Department and local housing service providers that have been selected by the County to implement eligible grant funded activities. CDBG program regulations require a minimum of 70% of funds be used to benefit low and moderate-income people. Seminole County seeks to use all its CDBG funding to benefit low and moderate-income populations.

## **Affordable Housing**

### AP-55 Affordable Housing – 91.220(g)

#### Introduction

The following federal funded grant programs, CDBG, HOME, and ESG described in the 2015-2019 Consolidated Plan have strategies to achieve affordable housing goals each year. The CDBG program supports affordable housing by providing funds for rehabilitation of owner occupied housing units, and through the acquisition, rehabilitation of existing housing units to be used as affordable rentals. The HOME program supports affordable housing for low and very low-income households by providing rental assistance, creation of new units through construction or acquisition/ rehabilitation, and purchase assistance to homebuyers. The ESG program supports affordable housing by providing rapid re-housing activities to the homeless segment of the population. The HOME and ESG programs all set affordable housing goals to achieve each federal fiscal year, but the CDBG Program based its accomplishments on the beneficiaries served with housing rehabilitation funds each application cycle.

#### Discussion

Seminole County anticipates using HOME funds to produce 4 new affordable housing units during the 2019-2020 fiscal year. The affordable housing units will be targeted to low-moderate income persons and families, including special needs populations. HOME Tenant based rental assistance (TBRA) will provide assistance for at least 30 eligible elderly and/or disabled individuals. CDBG funds will also be used to acquire and rehab 3 units for affordable rentals. Seventeen homeless households will be assisted with ESG Rapid Re-Housing activity funds to reduce homelessness.

## AP-60 Public Housing - 91.220(h)

#### Introduction

The Seminole County Housing Authority develops, owns and operates a 30-unit public housing development located in Oviedo, Florida, within county limits. The Housing Authority also operates a Section 8 rental assistance voucher program and accepts applications for rental assistance directly from the public. To maximize the Housing Authority's efforts of serving Seminole County residents, the County provides CDBG funding for supportive services and infrastructure projects to the housing authority upon request during the annual Request for Application (RFA) process.

#### Actions planned during the next year to address the needs to public housing

The County does not currently have any actions or projects planned for the 2019-2020 fiscal year because the Seminole County Housing Authority did not submit a request for funding during this year's RFA process.

## Actions to encourage public housing residents to become more involved in management and participate in homeownership

The Seminole County Housing Authority provides internal programs and supportive services to its clients to establish self-sufficiency and move to homeownership. Supportive services include job training, financial counseling, networking with housing providers, etc. These supportive services are offered to all public housing residents as incentive to take control of their housing opportunities and better their lifestyle. In FY 2018, one public housing resident purchased a new home and successfully existed the program. Currently, The housing Authority is working with another resident toward homeownership.

#### Discussion

Seminole County does not anticipate using any HUD federal funding on projects that promote, benefit, or support public housing projects or activities during the 2019-2020 fiscal year. The Seminole County Housing Authority will continue to administer direct annual HUD funding allocations on the operation, maintenance, and rental assistance projects and activities based on the amount of the allocation and the number of qualified individuals and families in need of public housing assistance. Seminole County is an active participant in the Choice Neighborhoods Initiative that seeks to revitalize the Goldsboro Neighborhood. The initiative will address plans for addressing properties owned by the Sanford Housing Authority as well as other properties within the boundaries of their study area.

## AP-65 Homeless and Other Special Needs Activities – 91.220(i)

#### Introduction

In this section of the 2019-2020 Annual Action Plan, we outline strategies that will be implemented to achieve one-year goals and objectives aimed at addressing the needs of the homeless and other special needs populations. These strategies will be implemented by the County through collaboration with selected housing providers that provide direct services to the target populations. Each of the following sections will describe the methods of outreach to homeless persons, activities to address the emergency shelter and transitional housing needs of homeless persons, actions to assist homeless persons with obtaining permanent housing, and efforts to prevent homelessness to reduce and end homelessness throughout Seminole County.

# Describe the jurisdictions one-year goals and actions for reducing and ending homelessness including

# Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

The Homeless Services Network of Central Florida serves as the Homeless Continuum of Care (CoC) agency and partners with providers throughout the Central Florida region to implement Street Outreach activities and conduct and report the annual Homeless Point-in -Time (PIT) Count. Through these efforts, HSN assists homeless service providers in developing and implementing strategies to address the needs of sheltered or unsheltered homeless persons. Seminole County Currently provides funding for the Street outreach activities through partnership with Aspire Health Partners.

In addition, Seminole County Community Services Department partners with Embrace Families and Catholic Charities of Central Florida to administer rapid re-housing activities, including case management and assessment through the ESG RRH Program and anticipates continuing to do so during the 2019-2020 fiscal year. The project is included in the FY 2019-2020 Action Plan.

#### Addressing the emergency shelter and transitional housing needs of homeless persons

Seminole County, in partnership with three local non-profit homeless services providers, anticipates providing ESG funding to assist homeless persons who need shelter or are residing in emergency shelters. The County plans to provide \$36,000 in ESG funding to Safehouse for eligible operation and maintenance expenses to assist approximately 250 individuals who need shelter or are currently residing in emergency shelter or transitional housing facilities owned and operated by the organization. Finally, the County plans to provide \$25,000 in ESG funding to Recovery House for eligible operation and maintenance expenses to assist approximately 40 individuals who are in need of shelter or are currently in emergency shelter or transitional housing facilities owned and operated by the agency. The funding of these activities will assist in achieving the one year goals by providing shelter operating costs and rapid

re-housing assistance for the homeless.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

The Community Services Department administers and supports several projects to help homeless persons make the transition to permanent housing. The County supports the Housing First Model emphasizing housing placement followed by wrap around supportive services. In addition, Community Services Department is currently implementing several strategies to facilitate access to affordable housing including acquisition, rehabilitation and rental of affordable housing for homeless families in Seminole County. In addition, County owned vacant parcels are also being considered for the development of affordable housing for homeless families and other eligible low-income households.

The County also partners with non-profit homeless services providers to implement affordable housing activities that directly affect the homeless population. Eligible affordable housing providers are encouraged to apply for annual funding allocations to promote and implement affordable housing activities, for all segments of the population, during the County's advertised Request for Applications (RFA) procurement process each fiscal year. Applications received are evaluated based on project scoring criteria.

Seminole County anticipates allocating \$ 49,500 of ESG Funds for rapid re-housing activities for extremely low and very-low-income families to avoid homelessness. This funding is anticipated to assist 17 households with direct financial assistance in the form of short -term rental assistance, security deposits, utility payments, or moving costs. Other eligible types of rapid re-housing assistance include housing search and placement, housing stability case management, mediation, legal services or credit repair. Recipients of the ESG Rapid Re-Housing assistance will be carefully evaluated by program criteria developed by the County, based on the federal ESG program regulations. Priority will be given individuals or families that present the most urgent need. CDBG funds are also planned to support case management services provided by a non-profit homeless services provider to households that are in a rapid re-housing program.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); or, receiving assistance from public or private agencies that address housing, health, social services,

#### employment, education, or youth needs.

The Seminole County Community Services Department administers an internal housing financial assistance program that provides rental, utility, and mortgage assistance to qualified families who are experiencing financial hardship due to job loss, medical problems, elderly and disabled garnishments, and more. The rental, utility and mortgage assistance program is funded through Seminole County general revenue funds, and can be applied for directly through the Community Services Department.

The Community Services Department also works in partnership with local mental health services, healthcare, and housing supportive services providers to supplement funding resources needed for qualified applicants, including low-income individuals and families, and extremely low-income individuals and families, and persons with special needs being discharged from publicly funded institutions and systems of care. Community Services currently partners with Catholic Charities-Pathways to Care Program to provide medical care and housing for homeless persons with special health care needs who are being discharged from hospitals with no planned housing placements.

#### Discussion

The Seminole County Shelter Plus Care Program is an internally administered program that provides rental assistance and case management services to chronically homeless persons with disabilities. Applicants are identified and prioritized via the Homeless Continuum of Care Centralized Assessment System managed by the Homeless Services Network. Services are leveraged with State Funding which provide matching funds for case management services. Seminole County also uses HOME funds to provide Tenant-Based Rental Assistance (TBRA) to elderly persons and persons with disabilities many of whom are extremely low-income.

### AP-75 Barriers to affordable housing – 91.220(j)

#### Introduction:

As a part of the Consolidated Plan process, Seminole County creates a report titled the *2015 Analysis of Impediments to Fair Housing Choice*. Within this report the Seminole County Community Services Department, in partnership with Langton Associates, Inc., conducted a comprehensive review of barriers to affordable housing and created resolutions to implement to eliminate the barriers identified. Prior to the development of this report, Seminole County conducted seven public meetings throughout the county to gain public input from fair housing enforcement agencies, fair housing advocacy groups, local governments and the public about current or potential impediments that were affecting fair housing choice in all regions of the state. One important aspect of the report was the in -depth review of Florida's statutes, laws and policies that affect fair housing choice, and includes recommendations on how to eliminate any potential barriers caused by the policies.

During the in-depth review of the Florida statutes, laws and policies, it was concluded that the Chapter 163, Part II, F.S., Growth Policy; County and Municipal Planning; Land Development Regulation; Community Planning Act (Sections 163.3161- 163.3217, F.S.) and Chapter 760, Part II, F.S., Florida Fair Housing Act {Sections 760.20 - 760.37, F.S.) have the biggest impact on fair housing choice regulation for local governments. These two specific laws outline requirements for housing development and define and prohibit discrimination in relation to fair housing choice. Though, neither were found to have direct negative impacts on fair housing choice were discovered when laws were not being properly enforced by local governments, or if land use regulations had the potential to restrict housing choice or propose housing development in areas of communities that could restrict access to goods and services required to achieve a safe and decent living environment.

Furthermore, public policies such as tax policies affecting land and other property could have a negative impact if the tax rates are increased for low-moderate income homeowners. Public policies such as land use controls, zoning ordinances, and building codes could have a negative effect on goals and objectives in this Consolidated Plan if is discovered that any of these public policies limit or even restrict the type of housing development desired to achieve a goal or objective. It is a priority of the County to ensure local housing policies and procedures are closely monitored and evaluated to remove barriers to affordable housing.

Actions it planned to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the

### AP-85 Other Actions - 91.220(k)

#### Introduction:

This section outlines the actions that the County will take to address obstacles to meeting underserved needs, foster and maintain affordable housing, reduce lead-based paint hazards, reduce number of poverty-level families, develop institutional structure, and enhance coordination between public and private housing and social services agencies.

#### Actions planned to address obstacles to meeting underserved needs

Funding limitations were identified as the primary obstacle to meeting the needs of the underserved in the development of the Consolidated Plan. The funding limitations impacted the Neighborhood Revitalization goal most of all, requiring the phasing of the Midway Water project over several program years. During FY 2019-2020 Seminole County will continue with Phase 3 of the of the improvement project. In addition to phasing larger projects, Seminole County seeks opportunities to coordinate and effectively leverage funds to continue Neighborhood Revitalization Efforts County wide.

#### Actions planned to foster and maintain affordable housing

Seminole County anticipates allocating over \$1.6 million toward eligible federal grant funded activities that foster and maintain affordable housing. Specific activities planned include homeowner rehabilitation, tenant-based rental assistance, and purchase assistance to homebuyers. In some cases, the County will be directly funding rehabilitation activities using County procured contractors and maintaining beneficiary case files in house, and other times will use County approved CHDOs or non-profit housing providers to carry out the activities that foster and maintain affordable housing.

To prevent affordable housing units becoming lost from the assisted housing inventory the County continuously monitors Mortgage Deed and Notes that have active Affordability Periods for compliance. If the units are not in compliance, then the necessary measures are taken to bring the units into compliance or recapture the funds. Community Services staff enforces and monitors all federal and State funded housing projects though Restrictive Use Covenants (RUC).

#### Actions planned to reduce lead-based paint hazards

Seminole County requires that all contractors complete a detailed work write-up to document a lead based paint hazard risk prior to construction on any affordable housing activities:

- If the building was constructed in 1978 or after, the construction date of the unit and source of information is to be recorded on the form.
- If the building was constructed before 1978, it requires visual inspection unless one of the following exceptions apply: a) No children under the age of 6 reside in the home. b) A previous

lead based paint inspection has been conducted according to the HUD regulations and the unit was found not to have lead based paint, documentation must be attached. c) The property has identified and all lead based paint has been removed in accordance to HUD regulations. Documentation must be attached.

- If the building was constructed before 1978 and does not meet any of the exemptions above, the following actions must be taken: a) a brochure concerning lead based paint hazards is to be provided to the household. b) The client is to be provided with a Disclosure of Information on Lead Based Paint. c) The home must be visually inspected. The preparer must, at a minimum, complete HUD's online visual inspection training before the inspection is conducted. The inspecting party must answer the following questions:
- Are interior painted surfaces free from deteriorated paint?
- Are the exterior painted surfaces free from deteriorated paint?
- Will any paint be disturbed during rehabilitation?

In accordance with the HUD Lead-Based Paint Regulation (24 CFR Part 35), rehabilitation work on housing built before 1978 that is financially assisted by the Federal government is subject to requirements that will control lead-based paint hazards. At the very least, Seminole County will test and repair any painted surface that is disturbed during the work. The County may stabilize deteriorated paint, which includes the correction of moisture leaks or other obvious causes of paint deterioration.

Clearance examination will be conducted following most work activities to ensure that the work has been completed; that dust, paint chips and other debris have been satisfactorily cleaned up; and that dust lead hazards are not left behind. As necessary, a risk assessment will be done to identify lead-based paint hazards, perform interim control measures to eliminate any hazards that are identified or, in lieu of a risk assessment, perform standard treatments throughout a unit. The type and amount of Federal assistance and rehabilitation hard costs for the unit will determine the level of lead hazard reduction that will be completed.

Actions to address LBP hazards and increase access to housing without LBP hazards include:

- Ensure that contractors completing work write-up on housing units are certified to complete the proper testing
- When selecting homes for rehabilitation/resale, give priority to homes that were constructed after 1978
- Coordinate with the local health department to maintain statistics on housing units identified to contain LBP

#### Actions planned to reduce the number of poverty-level families

The County currently implements several programs specifically geared toward assisting poverty level

families to reduce poverty over this five-year planning period.

The Community Services Department uses Community Services Block Grant (CSBG) funds to provide support and resources to eligible households including rent, utility, and scholarships for vocational and technical training certification. This program is intended to increase the earning potential of the head-of-household and therefore increase the household income which will decrease the amount of families in poverty.

The Tenant-Based Rental Assistance program provides rental subsidies to households that are at or below 30 percent of the area median income guidelines with elderly and/or disabled head of household. This program allows these households to maintain affordable housing with limited income. Therefore, it decreases the amount of people in poverty.

The Shelter Plus Care program provides rental subsidies and case management for chronically homeless and disabled individuals. This plan targets homeless individuals and provides a stable living environment while providing case management to help stabilize the individual, which will reduce the number of individuals in poverty.

The ESG Rapid Re- Housing program assists homeless families with acquiring and maintaining housing by providing rental subsidies and case management for up to 12 months. This program targets homeless families and provides a stable living environment while providing case management to help stabilize and increase their household income, which will reduce the number of families in poverty.

The Prevention program uses general revenue dollars to assist families with rental, mortgage and utility assistance to prevent homelessness and maintain current housing. This program helps maintain housing which reduces the impact of poverty on extremely and very low-income households

#### Actions planned to develop institutional structure

In the event that any gaps or weaknesses in the current institutional delivery structure of implementing federal funding program activities are identified, the Seminole County Community Services Department will take all of the appropriate measures and implement any additional actions necessary to resolve those issues. The County, in conjunction with the municipalities, elected officials, citizens, non-profit agencies, and for-profit organizations, will continue networking and trying to assess what resident need and how best to meet those needs. Keeping the private and public sector aware of all services provided will be a key objective for the County. Seminole County will continue to seek partnerships meet

community need effectively.

## Actions planned to enhance coordination between public and private housing and social service agencies

Seminole County will continue to enhance coordination between public and private housing and social service agencies by encouraging partnership for County funded projects and strengthening existing networking abilities through County sponsored community events, workshops and conferences.

Furthermore, Seminole County will complete the following actions to enhance coordination between public and private housing and social services agencies:

- Seminole County will continue the annual Request for Applications process for local non-profit organizations to submit request for consideration of grant funding to carry out the goals and objectives set forth in this Plan;
- Seminole County will enhance coordination with the Homeless Services Network of Central Florida, and other local private homeless providers, to expand access to data and needs for Seminole County's homeless population through participation on various housing and homeless committees;

Seminole County will enhance coordination with public entities, such as the Seminole County Health Department, on issues such as lead based paint data collection and reporting and through public events promoting health and wellness

#### **Discussion:**

Seminole County's Office of Economic Development and Community Relations works with existing and new businesses operating in Seminole County. The County offers a job growth incentive to support industries that are expanding their workforce for new jobs that will make a wage equivalent to 100% of the average County wage. Businesses can apply for this job incentive directly to Seminole County. Additionally, Seminole County supports economic development and new job growth through partnership with the State of Florida Department of Economic Opportunity, and provide required match funding for businesses that qualify for incentive funds through their Qualified Targeted Industry Tax Refund (QTI) program, available for companies that create high wage jobs in targeted high value-added industries. This incentive includes refunds on corporate income, sales, ad valorem, intangible personal property, insurance premium, and certain other taxes. Seminole County is responsible for 20 percent (20%) of the qualified businesses tax refund for those eligible within the jurisdiction.

The local Continuum of Care implements a coordinated entry system which is integrated into the Homeless Management Information System (HMIS). The coordinated entry system is used to prioritize housing placements for permanent supportive housing and rapid rehousing. Priority are established based on the Vulnerability Index-Service Prioritization Decision Assistance Tool (VI-SPDAT) to evaluate, prioritize intake, and coordinate the delivery of services to these homeless populations. The system has been in place for three years. Regular coordination meetings to assist in housing placements occur weekly. Seminole County ESG sub recipients are required to use HMIS.

3. Identify the process for making sub-awards and describe how the ESG allocation available to private nonprofit organizations (including community and faith-based organizations).

Seminole County publishes a Notice of Funding Availability (NOFA) each year to solicit the submission of proposals under the County's entitlement programs CDBG, HOME, and ESG. Proposals are accepted for CDBG public facility, public services, as well as, HOME construction projects, and ESG shelter operations and rapid rehousing activities. Proposal are reviewed and scored by a Grant Review Team which makes recommendations to the Community Services Director and County Manager. The recommendations are also made available for Public Comment and then to the Board of County Commissioners for approval.

4. If the jurisdiction is unable to meet the homeless participation requirement in 24 CFR 576.405(a), the jurisdiction must specify its plan for reaching out to and consulting with homeless or formerly homeless individuals in considering policies and funding decisions regarding facilities and services funded under ESG.

Service providers are contacted and asked to participate in the public hearings in order to solicit feedback regarding the homeless and formerly homeless individuals.

Seminole County's Board of County Commissioners is made up of elected officials and does not have a homeless or formerly homeless individual serving in that capacity. Seminole County partners with the Homeless Services Network (HSN), the lead agency in the Continuum of Care. HSN has membership that represents the Homeless and formerly homeless populations. During the development of the FY 2019-2020 Action Plan, HSN was consulted. Seminole County also participates in CoC meetings for feedback.

5. Describe performance standards for evaluating ESG.

The following criteria will be used on an annual basis to evaluate the performance of ESG recipients:

The length of time individuals and families remain homeless.

- Reducing the length of time individuals and families remain homeless -within 30 days of eligibility completion- Track the length of time it takes to house an individual or family after determining eligibility.
- The extent to which individuals and families who leave homelessness experience additional spells of homelessness.
- Reducing the number of individuals and families who experience homelessness more than once -Track homeless individuals and families 90, 180, and 360 days after program completion.
- The thoroughness of grantees in the geographic area in reaching homeless individuals and families.

- Number of homeless individuals and families have been reached with our efforts to end homelessness in Seminole County- Track the number of individuals and families assisted in the County.
- Overall reductiof1 in the number of homeless individuals and families.
- Reduction in the number of homeless individuals and families Track the number of homeless individuals and families.
- Jobs and income growth for homeless individuals and families.
