- 1. Veteran of the Month, August 2018**, was presented to Sergeant Bobby J. Draughon on August 14th at the Board of County Mission meeting beginning at 9:30 am. Sergeant Draughon entered the United States Army on June 21, 2004, and was discharged on October 23, 2008, during that time he served as a forward observer for the 1st Brigade, 82nd Airborne Division, making over 40 Parachute Jumps with a deployment to Afghanistan and an additional deployment to Iraq combined for over 25 months. Sergeant Draughon after the military became a Seminole County Probation Officer and subsequently a Police Officer at the Oviedo Police Department. His military awards include 3 Army Commendation Medals, Iraq Campaign Medal, Afghanistan Campaign Medal, NATO Medal, Combat Infantry Badge, US Army Jump Wings, and numerous other awards and decorations, his Oviedo Police Department awards include 6 Unit Citations, Humanitarian Award, Chief's Special Award and the Lifesaving Award. Sergeant Draughon hearing that an acquaintance, Seminole County Sheriff's Deputy Blayne Badura, was in desperate need of a kidney, he unselfishly offered to donate his own kidney, when it was not a match he volunteered for a program which traded kidneys nationwide ultimately saving four lives including Deputy Badura and another Seminole County resident living in Winter Springs. Sergeant Draughon has brought great credit and distinction upon himself, the United States Army, his country, and Seminole County. Sergeant Bobby J. Draughon, we honor you.

When? – Thursday September 27, 2018, from 10:00 am – 1:00 pm; Where? – Westside Community Center Boys and Girls Center, 919 Persimmon Avenue, Sanford, FL 32771. Currently scheduled to speak are the Director of the Orlando VA Medical Center, Manager of the Veterans Benefits Administration, Director of the National Cemetery Administration; there will be time for questions and answers and a Vietnam Pinning Ceremony. Additionally, your Seminole County Vet Staff will be there to assist.
- 3. Altamonte Springs designated as a Purple Heart City – Ed sends** – On August 7th, 2018, I was honored to be in attendance when Altamonte Springs Mayor Pat Bates read a proclamation designating Altamonte Springs as a Purple Heart City. Representatives of the Central Florida Chapter of the Military Order of the Purple Heart was there to accept the Proclamation and to present to the city a plaque recognizing Altamont Springs as its newest Purple Heart City. An audience numbering over 100, including nine Purple Heart recipients and three active duty witnessed this event. This designation is given by the state Military Order of the Purple Heart as a thank you to Veterans and a reminder to the community of the sacrifices servicemen and women have made. A Purple Heart is awarded to any armed forces member wounded or killed in combat. Other Seminole County cities, and the Seminole County School Board, are working toward this designation. Well done and thank you Altamonte Springs, you honor our Combat Wounded and you respect our Veterans. Seminole County was previously designated a

Purple Heart County on August 7, 2017. August 7th has been designated Purple Heart Day in the United States.

4. **Sanford to proclaim as a Purple Heart City on September 10th** – *Ed sends* – On Monday September 10th, the city of Sanford will offer a Proclamation to declare itself a Purple Heart City. The event will happen at the September Sanford City Commission meeting beginning at 7:00 pm with the Proclamation being accepted by members of the Central Florida Military Order of the Purple Heart. A meet and greet will begin at 6:30pm precluding the ceremony. This designation is given by the state Military Order of the Purple Heart as a thank you to Veterans and a reminder to the community of the sacrifices servicemen and women have made. A Purple Heart is awarded to any armed forces member wounded or killed in combat. The public is invited to attend. Thank you Sanford for honoring our Combat Wounded and showing great respect to our Veterans.
5. **R.E.D Shirt Fridays** – *Ed Sends I wear Red on Fridays, do you?* - from Marine Parents.com Beginning in 2005, military supporters across America started wearing red on Fridays to show support for the service members who protect our freedoms and way of life around the world. In the decade since, thousands of individuals, organizations, and businesses have taken up this cause and joined in observing "Red Fridays," as they've come to be known, to show their support for our men and women in uniform. This act of solidarity is intended to let American service members know that their sacrifices are recognized and appreciated, and that a grateful nation hasn't forgotten what those service members do for us on a daily basis. 6. **17,000 MOAA Members Rallied Together to Prevent TRICARE Fee Increases** MOAA, July 26, 2018, It was a heavy lift to ensure Congress did not raise TRICARE fees - and the MOAA membership was utterly amazing. It was an all-hands-on-deck effort, and it paid off. The House and Senate came out July 23 with combined FY 2019 National Defense Authorization Act (NDAA), which they negotiated during the last several weeks. MOAA was hyper-focused on a Senate-backed provision to significantly raise TRICARE fees for retired beneficiaries under age 65. We were pleasantly surprised to see the provision to end grandfathering and raise TRICARE fees did not make it in the final bill. [Read more.](#)

To update your information in some of the VA databases: (1) login to Vets.gov; (2) click on your name at the top right; (3) select profile; (4) click on edit for anything you wish to change; and (5) make your edits, and click update. However, these procedures will not work yet with all VA databases. To update: (1) education benefits, call 1-888-GIBILL-1 (1-888-442-4551); (2) home loan benefits, call 1-877-827-3702; (3) Veterans' Mortgage Life Insurance, call 1-800-669-8477; (4) prescriptions, call your health care team or your nearest VA medical center. The VA Mission Act is a three-way compromise between the Trump Administration, Congress, and vets themselves. The bill, signed into law by President Donald Trump earlier this month, provided \$5.2 billion in funding to keep the current Veterans Choice and Accountability Act running through next May while the Department of Veterans Affairs puts in place the VA Mission Act. Department of Veterans Affairs (VA) health care offers sick and disabled veterans options regarding the setting of their care and the types of care they receive. Long-term care services include: (1) nursing and medical care; (2) physical therapy; (3) help with daily tasks, like bathing, dressing and making meals; (4) comfort care and help with managing pain and (5) support for caregivers. Any health insurance you have in addition to TRICARE is known as 'other health insurance' (OHI). If you have OHI, it becomes your primary insurance and pays any claims before TRICARE does. Typically, having OHI can affect you if you are a retired TRICARE beneficiary who also uses Medicare, or if you are a spouse of an active duty beneficiary who also gains coverage through their employer. VSOs, including the Military Officers Association of America, Iraq and Afghanistan Veterans of America, Reserve Officers of America, Vietnam Veterans of America and Tragedy Assistance Program for Survivors, are calling on lawmakers to pass the bill this fall. Similarly, public views label veterans as community assets and leaders, but also assume veterans

38. **Federal Trade Commission Cracks Down on Sham Veteran Charities** MOAA, August 23, 2018, A Florida-based charity promising to help wounded veterans by soliciting \$11 million in donations has been banned from operating, according to the Federal Trade Commission (FTC). Regulators found nearly all of the funds received were spent on fundraising, expenses, and the founder's salary and benefits. Help the Vets Inc. and other groups, have been targeted by the FTC and law enforcement as sham charities "that con people by falsely promising donations will help veterans," according to an FTC press release. It's part of a larger FTC crackdown, in which more than 100 actions have been taken against sham charities in every state, the District of Columbia, American Samoa, Guam and Puerto Rico. A provision of the Harry W. Colmery Veterans Educational Assistance Act, known as the 'Forever GI Bill,' extends education benefits to this group of Purple Heart recipients effective Aug. 1. To qualify for the full benefit, you must have received a Purple Heart on or after Sept. 11, 2001, and have been discharged or released honorably. [Read more.](#)
