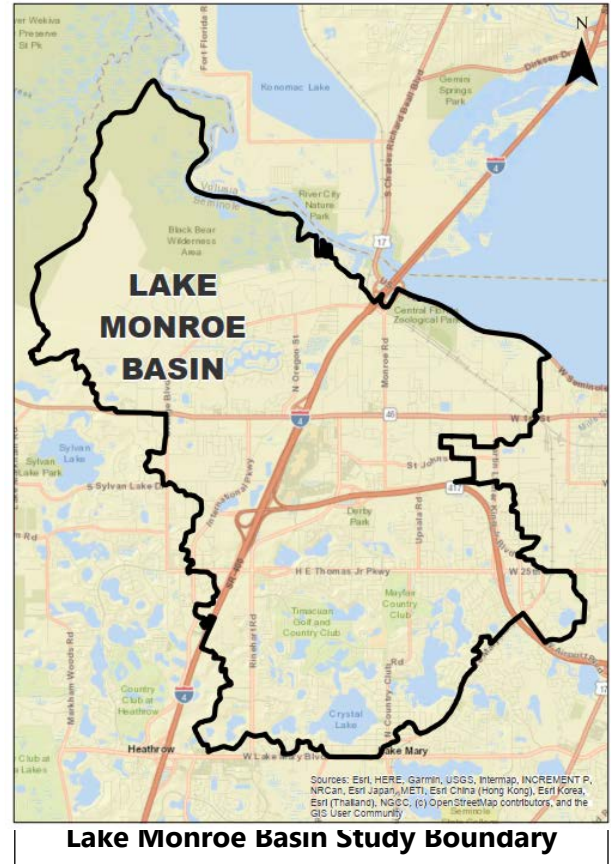

### Lake Monroe Basin Study BCC Districts 4 and 5

**Overview** - Seminole County Public Works Engineering Division has initiated an update to the 2002 Lake Monroe Basin study. This basin has received significant growth since the last study was completed. The update will incorporate developments built since the previous study was developed, identify flood-prone areas within the basin, estimate flood impacts to roadways and buildings, update the 100-year flood maps, and evaluate and rank up to twenty-five (25) potential Capital Improvement Projects that will serve to alleviate flooding within Seminole County.

The Lake Monroe Basin is located at the northwest corner of the County and drains to the St. Johns River or Lake Monroe. The watershed is approximately 24 square miles and resides within the St. Johns River Water Management District. It encompasses portions of the Cities of Sanford and Lake Mary, as well as a large portion of unincorporated Seminole County.



This public meeting is intended to share the status of the on-going study and present current findings from the updated stormwater models. Preliminary updated FEMA floodplains will be presented and provide residents and stakeholders and opportunity to view changes to the flood risk within the basin. A subsequent public meeting will be held at a later date to present the potential flood alleviation concepts.

**Public Meeting** - The County will be holding a hybrid (in person & virtual) public meeting with the virtual component utilizing Microsoft TEAMS.
