of the

#### SEMINOLE COUNTY BOARD OF COUNTY COMMISSIONERS

IDENTIFYING CERTAIN COUNTY ROADS WITHIN UNINCORPORATED SEMINOLE COUNTY IN THE ROLLING HILLS RESIDENTIAL AREA AS A DESIGNATED COUNTY FACILITY AS PROVIDED IN SECTION 34.30 (USE OF GOLF CARDS ON DESIGNATED COUNTY FACILITIES) OF THE SEMINOLE COUNTY ADMINISTRATIVE CODE; AND PROVIDING AN EFFECTIVE DATE.


WHEREAS, Seminole County Ordinance No. 89-28 created the Seminole County Administrative Code; and

WHEREAS, Seminole County Resolution Numbers 89-R-438 and 05-R-151 adopted the Seminole County Administrative Code; and

WHEREAS, the Board of County Commissioners desires to implement policies and procedures for permitting and regulating the operation of golf carts on Designated County Facilities located within the geographical limits of unincorporated Seminole County and under the jurisdiction of the County in accordance with Section 34.30 (Use of Golf Carts on Designated County Facilities) of the Seminole County Administrative Code, and

WHEREAS, the County Engineer received a Request from a representative in the Rolling Hills residential community to designate those roads listed in Exhibit A (Designated County Facilities List) as a Designated County Facility for the operation of golf carts as permitted in Section 34.30 of the Seminole County Administrative Code, and

WHEREAS, the County Engineer conducted an initial sufficiency review and determined the Request was consistent with Section 34.30 of the Seminole County Administrative Code and



Section 316.212, Florida Statutes (2019), and held a community meeting on November 21, 2019 with the area residents with the majority supporting the golf cart program; and

WHEREAS, the County Engineer notified the Seminole County Sheriff's Office who had no objection to allowing golf carts on the local street as provided in this Resolution, and

WHEREAS, the County Engineer reviewed the request and in accordance with best practices in the industry, and with local, state, and federal design standards and guidelines and made the following determinations in accordance with Section 34.30 C(6) and (7) of the Seminole County Administrative Code:

(a) Golf Carts may travel on and across the County roads listed in Exhibit A considering factors including the speed, traffic volume and character of motor vehicle traffic using these roads, and input from the Seminole County Sheriff's Office.

(b) All Designated County Facilities listed in Exhibit A Designated County Facilities have a posted speed limit of twenty-five (25) miles per hour or less; and

WHEREAS, the County Engineer issued an initial determination of approval and now recommends the roads listed in Exhibit A be identified as Designated County Facilities in accordance with Section 34.30 of the Seminole County Administrative Code; and

WHEREAS, Sections 316.212 and 316.313, Florida Statutes (2019), regulate operation of golf carts on certain roadways, and child restraint requirement respectively,

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Seminole County, Florida that:

Section 1. Incorporation of Recitals. The above recitals represent the legislative findings of the Seminole County Board of County Commissioners supporting the need for this Resolution.

**Section 2.** The roadways listed in Exhibit A (Designated County Facilities) are hereby identified as Designated County Facilities for the purpose of allowing the operation of golf carts.
