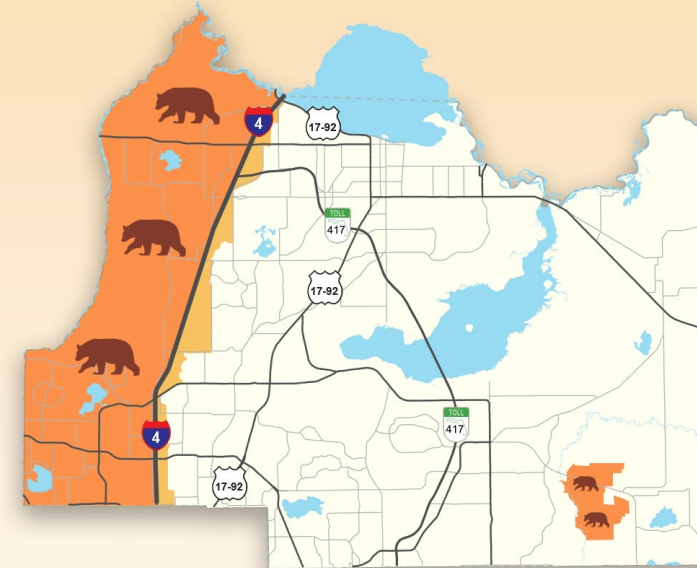

HOW DO I KNOW IF I LIVE WITHIN THE URBAN BEAR MANAGEMENT AREA?

The County website, BearAwareSeminole.com, has a link with the Urban Bear Management Area map, as well as a tool called UBMA Address Look Up. You may also call customer service at 407-665-2260.

WHAT IS THE CAUTION ZONE?

The Caution Zone is a small area east of I-4 that is highlighted in yellow. This area is currently being monitored for potential future restrictions.

QUESTIONS AND ANSWERS ABOUT REFUSE COLLECTION IN SEMINOLE COUNTY'S URBAN BEAR MANAGEMENT AREA



DO I NEED TO PURCHASE A BEAR RESISTANT CONTAINER?

No, the Ordinance does not require residents to purchase a Bear Resistant Container.

WHEN CAN I SET MY TRASH OUT FOR PICK UP?

Residents are prohibited from setting their can out before 5:00 a.m. on their collection day unless they utilize a Bear Resistant Container.

WHERE IN SEMINOLE COUNTY DO THESE RULES APPLY?

The restrictions on refuse placement applies to areas west of I-4 (see map on opposite page).

HOW CAN I PURCHASE A BEAR RESISTANT CONTAINER THAT IS APPROVED BY MY HAULER?

- Residents who wish to utilize a Bear Resistant Container may check their local home improvement store, or look online.
- A list of approved containers can be found at BearAwareSeminole.com, in the "For Residents" section.
- Please check with your HOA, City or local County Government for any applicable rules based on container type and size.

Any responsible party found to be in non-compliance of the ordinance is subject to enforcement and penalties including a penalty of \$100 per violation.

DOES THE ORDINANCE INCLUDE COMMERCIAL CUSTOMERS?

All Commercial Refuse Customers within the boundary are required to utilize a Bear Resistant Container or retrofit their existing container to their hauler's specifications.

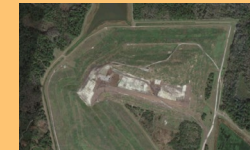
