Commissioner Van Der Weide suggested that Karen contact Diane Eswine to let her know about the concerns with re-applying for the Cultural Affairs Grant in June depending on the state budget approval of the Cultural Affairs Department budget. Diane would pass this information onto the County Manager Cindy Coto under Commissioner Van Der Weide's direction. There has been a new grant company hired for the county.

A brief discussion ensued about how the property tax reduction income loss, would affect the county and its special projects. Home owner's insurance is the driving force behind the surge in the increase of insurance premium in everyone's opinion.

#### Student Museum request:

Miriam Garrett from the Student Museum which is run by the Seminole County School board requested the following:

She wanted permission to be able to re-print the Historical Commission book, "Early Days" and wanted to include them in her school packets for the 4<sup>th</sup> grade teachers at the Student Museum.

The Early Days book was created by the Historical Commission. The research, edits and re-prints are under the control of the Historical Commission and the Museum's county Budget. These books are given out FREE to anyone that **VISITS** the Museum of Seminole County History. There are only 1,000 printed each year.

Karen provides a copy of the "Early Days" books to each teacher when she does her outreach during the years. She also provides the book to all teachers representatives from all schools during the classes before school actually starts in August. (teacher work days)

Many school libraries including elementary, middle and high schools have been given the "Early Days Book."
