The map is almost complete and the Historical Society has approved a contribution of \$325 for the glazing of the map. SGTV has done 27 minutes of video of the restoration and will complete the video with three minutes for the rededication.

**Accession Subcommittee**

#### **Exhibits Subcommittee**

Ms. Nelson gave the report in Mr. Zuromski's absence. She distributed a list of the display's for the 'Weird, Strange and Unexplained in Seminole County' exhibit. Discussion followed. The exhibit is scheduled to open on September 21<sup>st</sup>. Ms. Nelson recommended installing a fiberglass horse with the Longwood carriage exhibit rather than trying to remove the carriage in its current condition. She reported on sources she has found. Discussion followed. Alex Dickison made a motion for the County to use up to \$2,000 of the CROW funds to purchase a fiberglass horse as a permanent part of the Longwood carriage exhibit. Caroline Bistline seconded the motion. The motion passed unanimously.

# **Historical Marker Subcommittee**

o Mr. Tucker informed that he has pulled together the names that need to go on the second marker listing families involved in the cattle industry for the **Cattle Industry marker**. Unfortunately he left them at home. Mr. Hughes informed that the cost to install on a granite marker is \$1.50 per letter and he gave a very rough estimate that the second marker could cost approximately \$1,124.00.

# **Oral History Subcommittee**

- Mr. Batman informed that the volunteer, Ms. Ashley, had put together a spreadsheet
  of all oral histories which Seminole County is going to include in a booklet. Mr.
  Tucker requested a copy of the list. Ms. Ashley also created a 'How To' book on
