# **SUBCOMMITTEE REPORTS:**

## Natural Lands Subcommittee Report:

 Mr. Williamson reported that this month's meeting had to be cancelled due to Hurricane Irma. He reviewed the current status of the wilderness areas post hurricane. He also announced that Saturday, September 30<sup>th</sup>, is National Public Lands Day and there will be a free hike at Lake Harney W.A.

### **Trails** Subcommittee Report:

Mr. Brandenburg reported that County staff were unable to attend the meeting. The
County staff have provided Public Works Engineering with the Trails priority list. The
Seminole Wekiva Trail extension at State Roads 434 and 436 is under construction.
The Cross Seminole Trail missing link is getting closer to start completion. The widening
of SR 434 in Winter Springs offers the potential for a Cross Seminole Trail tunnel or
overpass. There was discussion of meeting with other counties regarding connecting
the trails.

- Mr. Criswell reported that they did not meet in September.
- Mr. Caldwell reported that the active parks reopened on Tuesday, Sept. 12<sup>th</sup>, after Hurricane Irma with minimal damage. The budget approved two new positions at the Sports Complex. The new software for Parks with online registration is due to go online January 1, 2018. The active parks have been set up with temporary mosquito spray stations.

#### **OLD BUSINESS:**

• Mr. Gibson reported that he had to reschedule a meeting with Comm. Dallari and will provide a report at the next meeting.

#### **NEW BUSINESS:**

- Mr. Brandenburg started a discussion about Little Free Libraries. They are small kiosk
  type places out of doors where books are available for free such as the one already
  located at Red Bug Lake Park. People take and drop off books. There was much
  discussion. Mark Brandenburg made a motion that the Parks and Preservation
  Advisory Committee recommend that the Leisure Services staff explore options for
  addition Little Free Libraries. David Williamson seconded the motion. The motion
  passed unanimously.
- Mr. Criswell announced that the next scheduled meeting would be the day before Thankgiving and suggested it be moved to either Nov. 15<sup>th</sup> or 29<sup>th</sup>. The majority supported the 29<sup>th</sup>. There was discussion of a different location. The majority requested Soldiers Creek Park. Staff will check the availability of the meeting room at Soldiers Creek and reserve it for Nov. 29<sup>th</sup> if available. Mr. Bowden requested a dry erase board be made available at the future meetings.

### **OTHER BUSINESS:**

- There was discussion about the County website.
- Mr. Caldwell reported that Paradise Marketing was awarded a marketing & advertising contract and Evok was awarded the social media part of the solicitation at yesterday's BCC meeting.
- Mr. Sturla requested a status on Rolling Hills. Mr. Caldwell provided the status.
