Animal Control Board -

I am sorry I will be unable to attend the Thursday, September 9, meeting of the Animal Control Board. As you know, Carole and I have been working on some modifications to the Animal and Fowl Chapter of the Seminole County Code. These include:

- Special protection for wild and exotic animals
- Addition of special magistrate.
- · Changes to the Animal Control Board to be an advisory role to Animal Services.
- Clarification of hobby breeders / pet sales.

In the future, we are looking into the following adjustments to the Chapter, but further research is needed on this activity:

- Limit number of animals in one (1) single resident in certain zoning areas (limiting hoarding of animals and puppy mills out of homes)
- Review of all fines / penalties for animal control issues.

There have been some questions related to the special magistrate. There are numerous reasons why I directed Carole to move in this direction:

- The magistrate will put us in sync with all other appointed boards in Seminole County,
- The same magistrate will serve to hear all appeals from building, planning, animal services, code enforcement, etc.;
- We are adding scope to hear appeals on citations.
- Appeals on licensing will also be included in the magistrate's review, and finally,
- · After an assessment of all counties in the State of Florida almost all utilize a legal entity for these tasks.

It will be my future plan to present with the Board on at each meeting. With the changes to the magistrate, the Animal Control Board will truly be able to focus on helping us adopt animals, create special events, advise on updates needed at the facility, and focus on ways to enhance our operation.

Since I have been given the responsibility of overseeing the Animal Services Division and appointed Carole Coleman as the manager, we have made some great changes. Many of you were part of these changes. These include:

- Hiring a full time veterinarian
- · Construction of a surgical center.
- Establishing the "Safe Place Drop Off" station no more dogs tied to the fence or front door hurting themselves.
- Establishment of an Isolation Building with protocols to protect animals from those who are sick and being treated, managed by our veterinarian
- · Demolition and construction of a new livestock barn
- Construction of a new dog play and obedience training area, adjacent to the Animal Services lobby.
- Shaded areas for all dog meet and greet yards, in partnership with TEARS.
- Improvement to the cat meet/greet area
- 24 hour Cat Cam
- Adoption Trailer for special events
- Additional disaster response trailer for pet-friendly sheltering during times of disaster
- BFF 100 program w/Seminole County Public School system
- Mobile printer units for Animal Control Officers in the field.
- New lobby with items available for sale/donations. All donations used for surgical procedures to help our animals.
- Adjusted policy for "owner surrender" not allowing persons to immediately adopt a younger animal.
- Addition of a classification of "aggressive animal" to enhance public safety in the community.
- 'Cat in the Window' inside the lobby which has bolstered adoptions of cats.
 Instead of walking into a bulletin board with flyers now the first thing people see is adoptable animals.

What is coming up?

- Complete renovation of the Adoption Building which will change to Stray building.
- Renovation of the Stray Building which will become the Adoption area closer to the lobby making it easier for people to get to see adoptable animals.
- Sun shades for new dog play / obedience training area.
- Dog walking trail around the outside of the shelter grounds
- Improvements to the cat room.

I look forward to working with you to continue to improve Seminole County Animal Services. I believe the quality and care of our animals is a critical function of the County. With your help, we can continue to save these animals and get them in good homes.

The following is a non-verbatim transcript of the Seminole County Animal Control Board (here in known as ACB) meeting held June 10th, 2021 at 6:00 PM, at 100 Eslinger Way, Rm #1-152, Sanford, FL. 32773,

- I Call to Order.
 - Stephen Browne called the meeting to order at 6:00 PM.
- II Roll Call.
 - o Roll Call was taken by the Clerk. A quorum was met.
- III Read "The Purpose (Function) of the Board (Section 20.05) was read by Stephen Browne.
- **IV Public Commentary**

Carla Wilson:

- 702 Heather Ln, Winter Springs, FL. 32708
- Ms. Wilson spoke on SB 96 Cross reporting of child and dog abuse, passed.
- Resale Pet Sales ban, 79 communities already including Seminole County, HSUS has taken this to Tallahassee, where it passed the Senate, but not the House.
- 6/22/21 Orange County will hold a meeting to vote on their retail puppy sale ban.
- Also offered a print out on Feral Cats so that the Board can have both side of the story on Feral Cats, since at a previous meeting a gentleman from Audubon Society spoke on Feral Cats killing birds.

V Minutes: March 11th, 2021

 Bryan Wilson made a motion to accept the minutes, the motion was seconded. The Board voted unanimously to accept the minutes.

VI Old Business

The discussion of the proposal that Dangerous Dog Appeals being heard by a special magistrate vs the Animal Control Board was continued. The Board reviewed the answers to the questions from the previous board meeting that was provided by the County Attorney. They discussed the 58 Counties that were polled about their Dangerous Dog hearings. Brian Wilson asked why the Animal Control Board was given that authority, in order to find that answer they would have to go back to the County Commissioner meeting minutes on the day the Ordinance was passed. Also, the question as to hiring outside legal representation was asked, and they County Attorney is not opposed to hiring outside legal counsel to help represent Animal Services. Stephen Browne voiced concern with this conversation because the magistrate is hired for the County, and that the only reason this conversation came up is because the County is frustrated that it lost, and he is concerned whether a magistrate would have the same compassion and understanding as the Board does. Stephen Browne also pointed out that the current system is flawed as the Administrator of Animal Services (Carole Coleman) is in a sense the investigating officer, and the prosecutor. Stephen Browne recommended to see if former Administrator, and Board Member Bob Hunter could be invited back to give his prospective since he had been on both sides of a Dangerous Dog Hearing. It was determined that the discussion would be continued to next meeting, and that Bob Hunter would be invited to be a speaker.

VII New Business

- The Board was informed that in April Animal Services was reopened to the public and would resume regular business hours and all normal operations with masks and social distancing guidelines.
- A Vaccine Clinic was held where 96 animals owned by the public received rabies vaccines, and 43 animals belonging to County Employees were given a full set of vaccines.

VIII Program Coordinator Report (Events)

- One Blood Bus comes to the shelter ever week, and donators receive one blood gifts as well as an adoption voucher they can use later.
- BFF program is currently doing kittens but may return to dogs in the fall.
- There are currently 146 cats or kittens in foster care and that includes the BFF program.
- Girls Scout troop made 4 benches for the lobby and the new turnout yard.

IX Kennel Statistics (Intakes & Outcomes),

 Stephen Browne mentioned that the stats dates need to be corrected. He asked if there is any truth to animals being returned due to returning to work, Carole stated we have not seen that at our shelter, but Orange County has reported it.
