#### Minutes

- The Committee voted unanimously to accept the 8/28/15 Minutes
- Steve Fussell provided updates to action items assigned to him
  - Steve presented a proposed schedule for AHAC meetings to meet compliance deliverables. The Committee reached consensus on continuing to schedule the meetings every three weeks. The next meeting will be 10/9. The meeting for public input will be held on 10/20 and recommendations to the BCC will be made during the 12/8/15 scheduled BCC meeting.
  - Steve shared a 09/14 opinion by planning and Development Division Manager Rebecca Hammock on the process whereby a developer can fast track permits for affordable housing. Special housing district zoning appears to be only for new housing. Mr. Williams asked if anyone has ever applied for it. Ms. Stolzenberg was not aware that it has ever been applied.
  - Steve provided copies of the Seminole County Government Charter that elaborates on economic impact review requirements.
  - Steve verified that Seminole County municipalities have all been formally invited to the AHAC meetings. The committee expressed appreciation that Andrew Thomas, City of Sanford, as in attendance.
  - Steve passed out copies of the Seminole County's Consolidated Annual Performance and Evaluation Report (HUD requirement) and the Local Housing Action Plan (State Requirement). The documents are large and will be accessible with a link on the new AHAC Knowledge Repository site.
- Carmen Hall provided a datasheet that detailed affordable housing accomplishments of Seminole County Government's programs.

- Sheryl Stolzenberg passed out information and provided insight into planning and zoning for Seminole County. Specifically:
  - Special housing district zoning: Special housing district zoning appears to be only for new housing. Mr. Williams asked if anyone has ever applied for it. Ms. Stolzenberg was not aware that it has ever been applied for.
  - Ms. Stoltenberg elaborated on requirements for rental units that might suggest the committee could perhaps recommend changes to zoning districts.
  - Per Ms. Binkley, perhaps residents do not have to recertify. Perhaps the committee could look at residents not having to recertify.
  - Perhaps these renters could be educated on case management and that landlords could partner with other nonprofits. Mr. Williams suggested that this is done by Habitat.
  - One idea is to create a policy that is less restrictive for renters and homeowners that might be now require owners to resell to low income residents.
- Ms. Snead expressed concern about the lack of communication between city and county plans.
- Ms. Smith emphasized the importance of all residents to research and participate in publically notices meetings.
- Ms. Smith asked about repeat offenders and affordable housing. Steve Fussell will provide information on lowering barriers for renters via new federal guidelines and processes being developed though the Central Florida Commission on Homelessness.
- Ms. Smith moved for adjournment, Alton Williams seconded the motion. Unanimous, meeting adjourned at 11:35.
