Oxford Rd Sidewalk and Drainage Improvements

From Derbyshire Rd to East Blvd And Derbyshire Rd from Glastonberry Rd to Chipola Trl

Overview - Seminole County Public Works Engineering Division is currently in the design process for sidewalks and drainage improvements along Oxford Rd and Derbyshire Rd. On Oxford Rd, existing sidewalks will be reconstructed from asphalt to concrete. New curb and gutter and concrete sidewalks will be constructed on the west side. Driveways and curb ramps will be upgraded to meet current ADA and County standards. Curb inlets and storm pipe will be constructed to replace damaged structures and pipe and improve drainage along the project. Along the north side of Derbyshire Rd, drop curb will be constructed to convey stormwater runoff.



Driveways and portions of sidewalk will be replaced to meet ADA and County standards. All proposed work is expected to occur within existing County right-of-way and easements. The project is funded by the 2014 Seminole County One Cent Infrastructure Sales Tax. This public meeting is intended to share the ongoing design and provide residents and stakeholders an opportunity to provide input.
