Old Business

1. **Review of recommended changes to Chapter 20 ordinance**
 - a. **Section 20.01 Definitions.** Adding definitions to define the following – Backyard Breeders, Bear Resistant Residential Refuse Containers, Community Cat, Community Cat Caretaker, Hoarding, Kennel License, Non-Community Cat, Secure Structure.
 - b. **Section 20.17 Animals at Large.** Adding that Community Cat

Trap-Neuter-Vaccinate-Return (TNVR) programs will be allowed in Seminole County. Exempting Community Cats from this section.

- c. **Section 20.20 Damage or Destroying Property; Injuring Persons or Animals.** Adding cats that have done harm or damage will be removed from that area where the incident occurred and may not be released into a cat colony.
- d. **Section 20.21 Odors.** Adding an Equestrian Property with one (1) or more acres would be exempt from this section.
- e. **Section 20.83 Standards of Care.** Adding dog and cat limits per household for those that don't obtain a kennel license. Directing Pet Owners and Community Cat Caregivers on feeding pets and community cats outdoors and storing food to have a minimal disruption to wildlife. Special requirements of food storage in any Urban Bear Management area.
- f. **Section 20.182 Retail Sale of Dogs and Cats.** Adding licensing requirements for over one (1) Litter per year. Disallowing Backyard Breeders in unincorporated Seminole County. Exempting Hobby Breeders in this section.

- a. Review the updated "Rules of Procedure" that reflects the ordinance changes that occurred in 2021 that affected the Function of the Board.
