Fatality Review

Mike had one fatality to review: January 29th, CR 426 near Seminole Woods Blvd. truck versus pedal cycle. It was noted that there is a county project scheduled for the future that includes paved shoulder areas that will give room for pedestrians and bicyclists to walk along side of the road way. Mike indicated he believed there was another fatality at 46A and Hartwell but he had not received the report. It was indicated there are possibly three this year with only one report being received.

Roadway Safety Assessment:

Slavia and 426 – DOT has to review and sign off

46A and I-4 - close

Tuskawilla @ Trail - Shad indicated consultant review

SR 434 and Markham – conflicting u turns with right turn overlap - after discussion, Robin recommended RSA review with Pete from SO and DOT.

Rinehart and 46A – conflicting u turns with right turn overlap

International Parkway and Westin – no way to dim LED's on equipment. Looking at specs for new equipment for 3 more intersections to be done (downtown Oviedo, Soldiers Creek and Orange Blvd.). Pete to see if this is still an issue at this location.

Problems & Solutions:

Obstruction at Markham Rd and Markham Woods Rd – limbs obstructing view and Mike went out and removed.

McCollough and Alafaya Trail – Mike did work order to restripe and replace RPM's on island with a 4' radius. Discussion ensued regarding jurisdiction of this intersection and Mike indicated he would obtain this information and advise. This is an important factor for court cases.

S. Sylvan Lake Drive – request to refurbish islands. Mike indicated he cleaned dirt and debris and would do a work order for restriping, etc.

There were several intersections mentioned that need sensitivity adjusted to cycle for motorcycles and Mike requested Pete forward a list to him.

Tuskawilla Road and Creekview Lane – citizen request for No U Turn sign – Traffic Engineering reviewed and declined.

Joe mentioned complaint regarding WB 434 at Lakefront Lane approaching Jamestown area. Motorists are ignoring traffic signs and citizen requested enforcement.
