## SR 434 Roundabouts Design – Jetta Point to Artesia Street

**Overview** – Seminole County is working in partnership with the Florida Department of Transportation (FDOT), District Five on the final design of SR 434 from Jetta Point, just west of SR 417, to Artesia Street to improve traffic operations and safety for motorists, pedestrians, and cyclists. The design includes roundabouts at Mactavandash Drive, Hammock Lane, and Artesia Street. The project design also includes a continuous shared-use path on the south/west side and a shareduse path/sidewalk on the north/east side of the roadway, providing access to the Cross Seminole Trail.

Changes to access management will occur upon construction of this project. This project builds upon the previous Corridor Planning Study, for which a Public Meeting was held in November 2019 and has been coordinated with local and regional agency partners including the City of Oviedo, City of Winter Springs, FDOT, and MetroPlan Orlando to identify and implement solutions to the corridor's existing and future needs.

**Public Meeting** – A public meeting will be conducted to present the preliminary design and receive public comments. An in-person and virtual meeting will be held on June 9<sup>th</sup>, 2022 from 6:00 – 7:30 p.m, which includes a short presentation followed by an open house for those attending in-person.

A presentation will begin at 6:00 p.m. There will be an opportunity to view project displays, speak with project team members, and provide comments after the presentation.
