County Incentives

The Board of County Commissioners has established a Jobs Growth Incentive (JGI) Trust Fund for both new and existing companies. Seminole County will consider providing incentive dollars for items such as training, relocation expenses and development costs for companies that satisfy selected job creation and wage criteria. Preference is given to new construction and to companies locating in targeted areas within the County.

RECENT PROJECTS & ECONOMIC PRIORITIES

The City of Longwood has focused its development efforts on preserving its history while carefully planning to ensure a sustainable future.

In 2006, Longwood began the important process of reevaluating its economic position in the region. Through a series of workshops and public hearings, the City Commission began to express a vision that will ensure continued growth while embracing enduring patterns of development and avoiding sprawl and its consequences. Armed with a detailed economic study, the City has designated visioning areas and adopted new design guidelines to ensure future development supports the City's vision plans.

In 2008, the City adopted an Evaluation and Appraisal Report that will shape the Comprehensive Plan for the next seven years. The City Commission remains committed to enhancing sustainability and creating transportation options, and have established guidelines for the development of a Transit Village in conjunction with the Central Florida Commuter Rail station, set to begin operation in 2011. Priority has been placed on linking new development with bus routes and pedestrian paths to reduce the need to drive long distances. By encouraging the development of jobs, homes, recreational activities, goods and services within the community rather than at the urban fringes, Longwood aims to preserve its beautiful historic core and enhance the quality of life for its citizens.
