

Public Meeting Notice Wekiva Watershed Management Plan Tuesday May 3 at 6:00 p.m.

Seminole County Public Works Department/Watershed Management Division has initiated the development of a Watershed Management Plan for the Wekiva Watershed (CIP# 1785376). The plan is being developed by Geosyntec Consultants, Inc. The purpose of this notice is to inform you of an upcoming public meeting and briefly describe the project scope of work, present the steps undertaken to develop the plan, and request your input.

The Wekiva Watershed comprises the western most areas in Seminole County that drain to the Wekiva River. This watershed is approximately 56.2 square miles (~36,000 acres) and resides within the St. Johns River Water Management District. This watershed is comprised of three drainage basins: Little Wekiva, Big Wekiva, and Yankee Lake.



Overview of the Plan

These basins have received significant growth in the last couple of decades. The update will:

- Incorporate developments and infrastructure improvements built since the previous study and any development that has occurred in the Wekiva Watershed
- Identify flood-prone areas within the basins
- Estimate flood impacts to roadways and buildings
- Update 100-year floodplains
- Evaluate and rank conceptual Capital Improvement Projects that will serve to alleviate flooding and improve water quality

This public meeting is intended to share the status of the on-going analysis, present the results of the data acquisition phase of the study, and provide residents and stakeholders an opportunity to provide information on local drainage concerns. An additional public meetings will be held at a later date to present the potential flood alleviation and water quality improvement projects, and updates to the floodplain maps.

Public Meeting Details

Due to the current COVID-19 related social distance measures enacted at the National, State, and County levels, the County will be holding a virtual public meeting using a Zoom platform, as well as an in-person meeting. Persons interested in attending the virtual meeting can join online by visiting and registering at the project website (see top of next page for details). Additionally, the virtual public meeting pre-recorded video presentation and any other pertinent information will be available online from May 1, 2022 to May 11, 2022 at the project website.

Both the virtual Zoom platform and in-person meetings will occur at the same time on Tuesday May 3, 2022 beginning at 6 p.m. See below for additional information on viewing options:

Attendees will have an opportunity to come view an informational presentation on the project, speak with project team members, view project informational displays, and provide comments.
