In 2022, Seminole County initiated the **2045 Transportation Mobility Plan** to serve as a guide for future Seminole County transportation improvements and investment decisions through 2045. The purpose of the plan is to identify transportation mobility needs that could be implemented over the next 20 years.

These mobility needs are prioritized based on how they align with the vision and goals of the community. The prioritized list of mobility projects will serve as a guide for identifying potential new capital improvement projects. Upcoming Public Meetings

Seminole County plans to hold public meetings to share more information about the **2045 Transportation Mobility Plan** and to provide the opportunity for public input. Public input is being solicited to identify additional mobility needs and to guide the prioritization of those needs for future implementation.
