## Participation Requirements for the EZ Permitting Program

- The contractor must be current in our permitting system with their license and insurance information.
   If your company is not, email the contractor license, the <u>License Administrative form</u> from our
   website, and the Certificate of Insurance (COI) for Workers' Compensation (or exemption card, not
   the application) and General Liability. The Certificate Holder should state, Seminole County 1101 E.
   1st St. Sanford FL, 32771.
- Email the notarized EZ Permits Authorization form with all authorized email addresses, personnel, and payment methods for your company to <a href="EZPermits@seminolecountyfl.gov">EZPermits@seminolecountyfl.gov</a>. The completed, notarized authorization form can be submitted by email, fax, mail, or hand delivery. This form will be kept on file for five (5) years; however, it can be updated at any time by the contractor
- See the second page for residential permit types that a contractor may submit through EZ Permits
  instead of our Electronic Plan Review system. You will <u>not</u> apply through Building Permits
  Online or upload files to ePlan. These submittals are by email only and from authorized personnel.
- The Property Appraiser's information determines the legal owner of record. Legal documentation (executed warranty deed) may be required if property ownership changes.
- Must be able to email legible PDF document(s) emailed to: **EZPermits@seminolecountyfl.gov**
- Once approved, you will be emailed the total amount due. PLEASE respond to the email chain
  notifying us that you have paid so we may issue the permit. We don't know you have paid until
  we are notified.

Our goal is same-day permit issuance for permit application packages received Monday through Friday by 2 p.m. We strive to keep this goal; however, on rare occasions, if the customer volume increases within a given day, you may receive it the following day. Again, please notify us promptly after payment so we may issue your permit.

The permit will be placed on hold until we receive a recorded NOC in our office.

NOTE: Condominiums are considered Commercial.

## **EZ PERMIT RESIDENTIAL TYPES FOR CONTRACTORS ONLY**

Once the EZ authorization form is accepted, all submittals are emailed and must include a permit application, the property card, and any supporting docs such as those below. If submitted without NOC, the permit will be issued and placed on hold for inspections until we receive a recorded NOC. A recorded NOC is required for a job value (labor and materials) over \$5,000. A/C change-out value of \$15,000+
